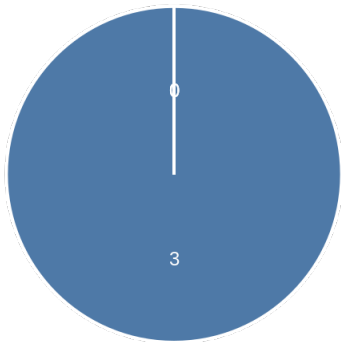
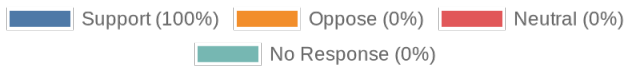

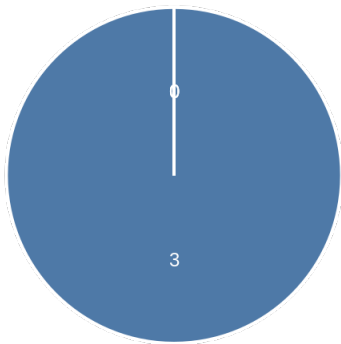

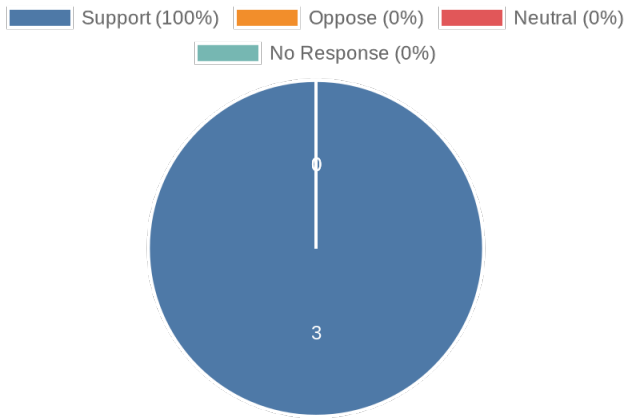

SB 357 by Scott the Wienerdog effectively bars police from investigating persons loitering with the intent to engage in prostitution-type activities. An unfortunate result is that, as the Board letter says, this has significantly limited early intervention opportunities and allowed trafficking networks to operate more freely in public spaces, often without fear of consequence.

Statewide, local law enforcement has reported a rise in visible street prostitution, open exploitation, and human trafficking in the wake of the implementation of SB 357. Without this enforcement mechanism, law enforcement

officers cannot intervene unless a more serious criminal offense has already taken place. San Diego is particularly at risk because of its proximity to Mexico. So yes, SB 357 needs to be repealed. It would help if you could shake up a few agencies in this County we know contribute to trafficking kids, like Child Welfare and Protective Services. Get the baddies out.
