These proposed ordinances will adopt the 2023 Consolidated Fire Code for the San Diego County Fire Protection District, ratify the 2023 Consolidated Fire Code for ~~all 13~~ Fire Protection Districts within the geographical area of the County of San Diego, including the San Diego County Fire Protection District, repeal the County Fire Code, and move requirements in the County's Defensible Space Ordinance to the Consolidated Fire Code. The proposed ordinances will be presented to the Board of Supervisors of the County of San Diego and the Board of Directors of the San Diego County Fire Protection District for the first reading on Tuesday, February 28, 2023. The proposed ordinances will be presented for adoption on Tuesday, March 14, 2023.

Those wishing to comment may either appear in person at the public forum, via teleconference, or submit written comments, which must be received by the County prior to the forum.
