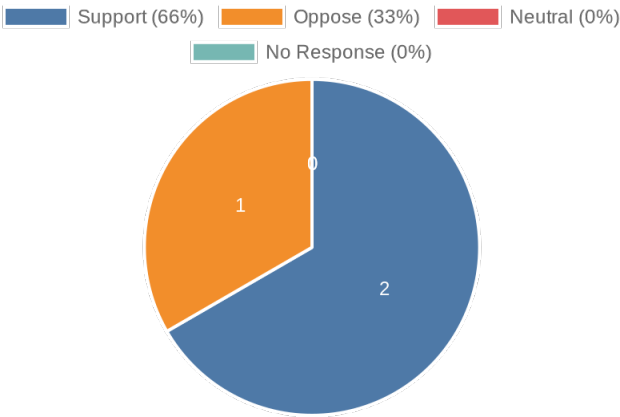

Overall Sentiment

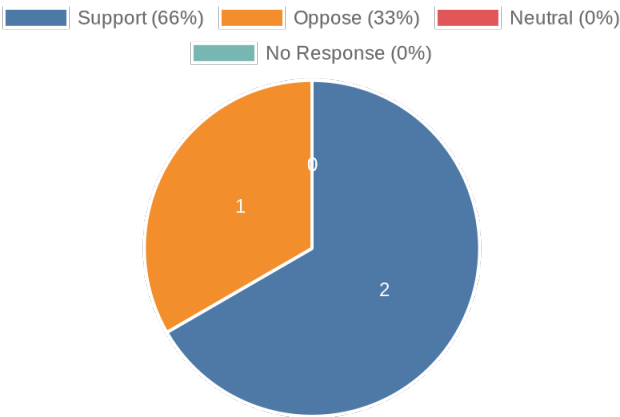

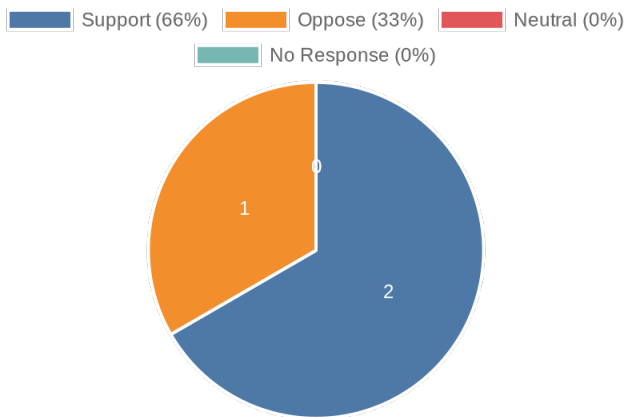

As a survivor of commercial sexual exploitation, I want to be very clear: repealing SB 357 will not protect victims — it will criminalize them.

When you bring back loitering laws, you are not targeting traffickers or buyers. You are targeting the people being exploited — the same people who are already traumatized, poor, homeless, or coerced. These laws give police a reason to stop, search, arrest, and jail victims for simply existing in public. That pushes us further into danger, not closer to safety. We already know who drives this industry; adult men — disproportionately older, white, and financially stable. They create the demand. Traffickers respond to that demand. But loitering laws never touch the buyers. If this county truly wants to fight trafficking, the focus should be on demand — the men who buy sex — and on funding housing, mental health care, legal support, and survivor-led outreach. SB 357 by Scott the Wienerdog effectively bars police from investigating persons loitering with the intent to traffick minors or other prostitution-type activities. As the Board letter says, this has significantly limited early intervention opportunities and allowed trafficking networks to operate more freely in public spaces, often without fear of consequence.

Statewide, local law enforcement has reported a rise in visible street prostitution, open exploitation, and human trafficking in the wake of the implementation of SB 357. Without this enforcement mechanism, law enforcement officers cannot intervene unless a more serious criminal offense has already taken place.

San Diego is particularly at risk because of its proximity to Mexico and its different justice system. So yes, SB 357 needs to be repealed.
