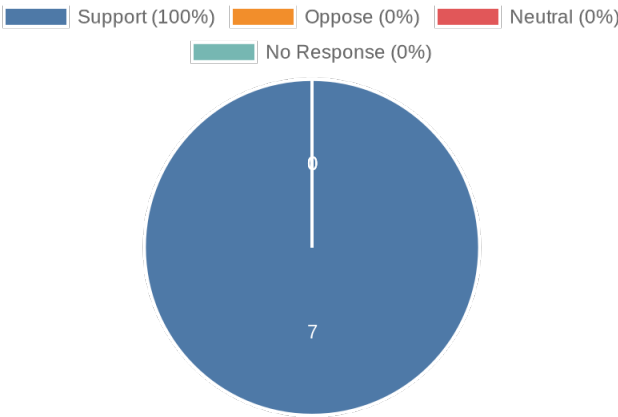

Overall Sentiment

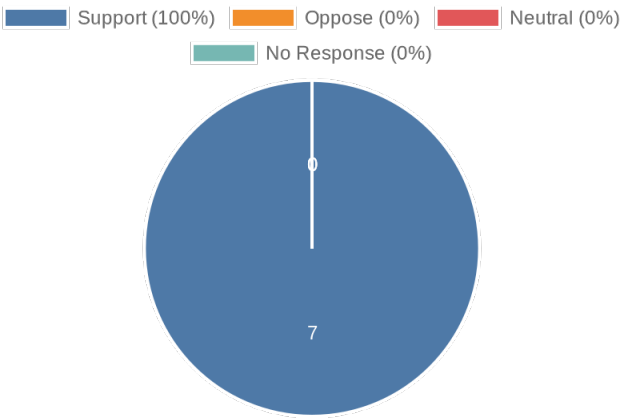

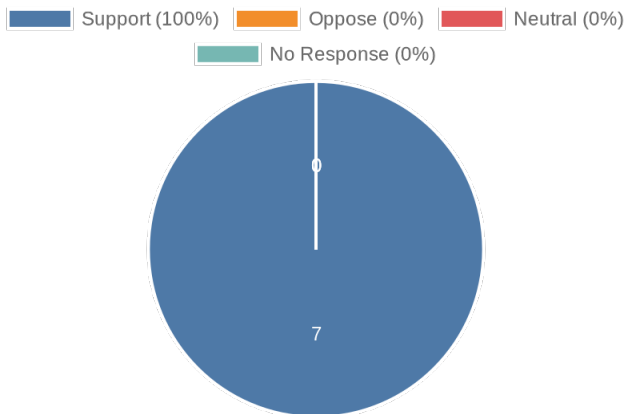
