

## CERTIFICATE OF PUBLICATION REGARDING NOTICE OF PUBLIC HEARING

This Certificate of Publication Regarding Notice of Public Hearing is delivered on the date set forth above for the purpose of demonstrating compliance with Section 147(f) of the Internal Revenue Code of 1986, as amended (the “Code”) and applicable Treasury Regulations (the “Regulations”). The undersigned, an Assistant Secretary of the California Enterprise Development Authority, a public entity of the State of California, created pursuant to Chapter 5 of Division 7 of Title 1 (commencing with Section 6500) of the Government Code of the State of California (the “Issuer”), hereby certifies as follows:

1. A Notice of Public Hearing containing the language attached as **Exhibit A** (the “Notice”) with respect to the plan of finance, the issuance of the bonds, notes or obligations (the “Obligations”) and the project described therein (the “Project”), was published on the Issuer’s primary website address of <https://ceda.caled.org/> on September 10, 2025.


2. The Notice was published in an area of the Issuer’s website which is used to inform members of the general public about public hearings to be held by member jurisdictions affecting them and which is clearly identified and accessible to members of the general public seeking information concerning the plan of finance, the issuance of the Obligations and the Project.

3. Evidence of the website publication of the Notice is attached hereto as **Exhibit B**. The Issuer will maintain records evidencing that the Notice was timely published as set forth in Sections 1 and 2 above for the period referred to in Section 4 below, and acknowledges it is responsible for maintaining such records.

4. The Notice remained continuously published on the Issuer’s website for the entire period of seven (7) or more days from the date of the original publication described in Section 1 above to the hearing date described in the Notice.

## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that on September 17, 2025, a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 (the “Code”) will be held by the California Enterprise Development Authority (the “Authority”) with respect to a proposed plan of financing providing for the issuance by the Authority of its revenue bonds for a qualified 501(c)(3) project pursuant to Section 145 of the Code in one or more series issued from time to time, including subsequent bonds issued to refund such revenue bonds in one or more series from time to time, in an amount not to exceed \$55,000,000 (the “Bonds”). The proceeds of the Bonds will be used to make a loan to Maison 613 (the “Borrower”), a California nonprofit public benefit corporation, whose sole member is Ascent 613, a California nonprofit public benefit corporation and an organization described in Section 501(c)(3) of the Code. The proceeds of the loan will be applied to: (1) finance and/or refinance the acquisition, development, construction, equipping and furnishing of an approximately 71-unit, 156-bed student housing project and related facilities, all located at 6115 Montezuma Road, San Diego, California 92115 and 5087 Rockford Drive, San Diego, California 92115 (the “Facilities”); (2) fund a debt service reserve fund for the Bonds, if any; (3) fund capitalized interest on the Bonds, if any; (4) fund working capital, if any; and (5) pay certain expenses incurred in connection with the issuance of the Bonds. The Facilities will be owned by the Borrower.

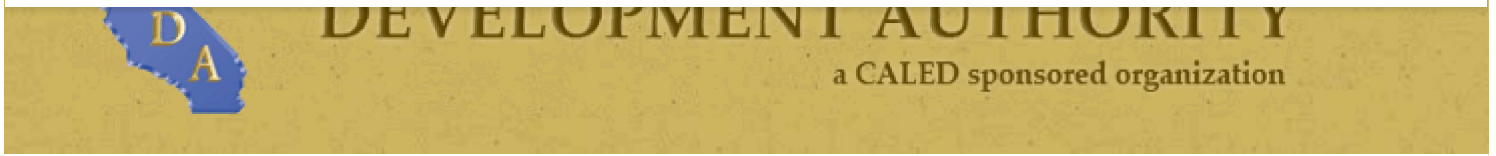
The Bonds, the obligation to pay principal of and interest thereon, and any redemption premium with respect thereto, do not constitute indebtedness or an obligation of the County of San Diego, the Authority, the State of California or any political subdivision thereof, within the meaning of any constitutional or statutory debt limitation, or a charge against the general credit or taxing powers of any of them. The Bonds shall be a limited obligation of the Authority, payable solely from certain revenues duly pledged therefore and generally representing amounts paid by the Borrower.

The hearing will be held by teleconference and will commence at 12:30 p.m. Pacific Time. Those wishing to comment on the proposed financing and/or refinancing and the nature and location of the Facilities and the financing and/or refinancing of the Facilities with the proceeds of the Bonds may access the teleconference by dialing (888) 788-0099 and entering conference ID number 86845056296 and participant passcode number 143577.
