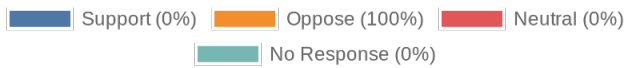

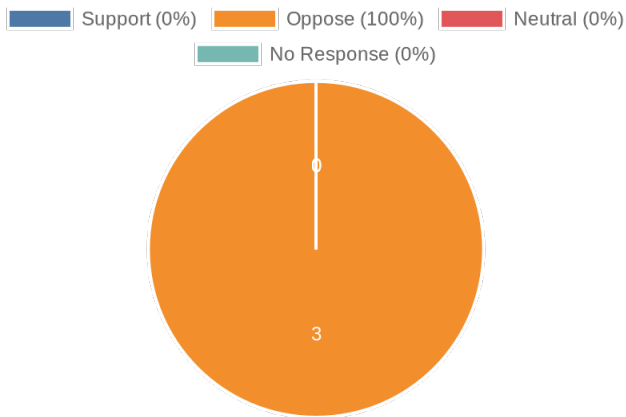

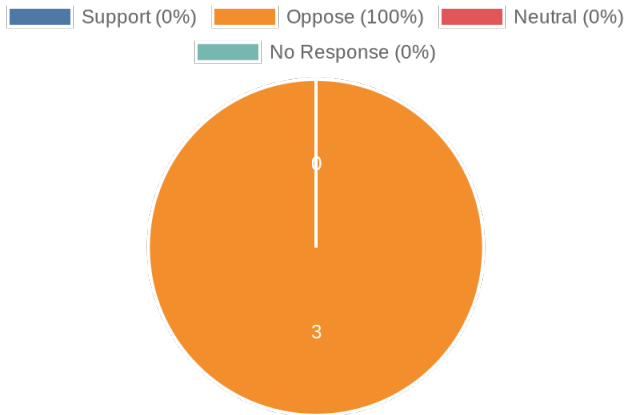

This government body overseeing mental health care, especially of minor children, is disturbing. A new Children's Crisis Residential Care facility, offers new crisis care to minors experiencing a mental health crisis. Be aware of state law AB 665 - Governor Newsome signed into law 10/2023: A child 12+ MAY CONSENT to mental health treatment or counseling on an outpatient basis, or to residential shelter services, if the minor, in the opinion of the attending "professional person", is mature enough to participate intelligently in the outpatient services or residential shelter services." Meaning the minor child can decide, with guidance of a "professional person", to leave the family home and enter a residential shelter without parental knowledge or consent. And without accusation, conviction or threat of abuse of the child by a parent. The parent is unaware their minor child is in a government residential facility. An easy pathway to a residential government facility is public school.
