





Federal, state, and local policies have shifted toward keeping children safely with their families instead of removing them into foster care—and that's the right approach. But these changes mean we need to rethink how we use resources like San Pasqual Academy. Equity matters: every child in foster care deserves access to the right placement and the right level of support. Yet last fiscal year, the entire 238-acre campus served just 49 youth, at a cost far exceeding most, if not all, other placement options. That raises tough questions about sustainability and fairness. This review isn't about eliminating choices—it's about ensuring our programs reflect today's realities, maximize impact, and balance compassion with fiscal responsibility. Every dollar matters, but so does every child and every family. By engaging stakeholders, we can design and implement a system that delivers equitable, effective care for foster youth and their families.

Are we talking about more reliance on home-based care for foster kids like Arabella McCormack who was starved, beaten, and tackled roughly by her Border Patrol father and churchworker Mom? Child Welfare and Child Protective Services need a personnel audit by an independent auditor.

Between that and the Polinsky Center abuses, you need to restore trust in your handling of Foster kids before you

place them with anyone but their family.

And you probably should interview the Foster Kids separately from the service providers and other stakeholders since they are more likely to tell the full story in that setting, as Audra and many social workers could tell you.
