**JOINT RESOLUTION OF THE COUNTY OF SAN DIEGO BOARD OF SUPERVISORS AND SAN DIEGO COUNTY FLOOD CONTROL DISTRICT BOARD OF DIRECTORS AUTHORIZING COUNTY AGENTS TO EXECUTE AND SUBMIT APPLICATIONS AND OTHER DOCUMENTS; AND ACCEPT FUNDS FROM AWARDED GRANTS TO AND FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY OR CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FOR THE COMMUNITY RATING SYSTEM**

**WHEREAS**, the Federal Emergency Management Agency has a Community Ratings System and

**WHEREAS**, the Community Ratings System is administered by the Insurance Services Office, Inc. (ISO),  
and

**WHEREAS**, in the County of San Diego, flood mitigation is important to protect lives and property;  
and

**WHEREAS**, participation in the Community Ratings System is essential if the County of San Diego, a public entity established under the laws of the State of California and the San Diego County Flood Control District, a flood control district formed and operation pursuant to Water Code Appendix section 105-1 et seq. (District), are to mitigate flooding.

**NOW, BE IT RESOLVED** by the Board of Supervisors of the County and the Board of Directors of the District, that the

Director, Department of Public Works, OR

Assistant Director, Department of Public Works, OR

Deputy Director, Department of Public Works, OR

Flood Control District Manager

is hereby authorized as agents of the County and District to execute for and on behalf of the County and the District all applications for the Community Ratings System, and to file those applications with ISO or such other state or federal agency as may be designated by the federal government for the purpose of receiving insurance premium discounts on behalf of the public; and that

The County and District hereby authorize their agent(s) to provide to ISO or such other state or federal agency for all matters pertaining to such discount program the assurances, agreements, and any other documents that may be required.
