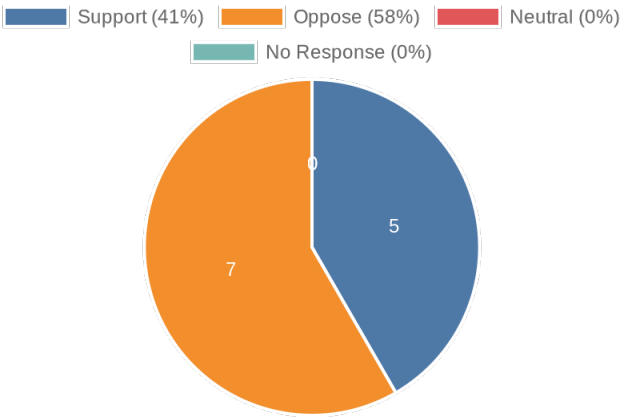

#### Overall Sentiment

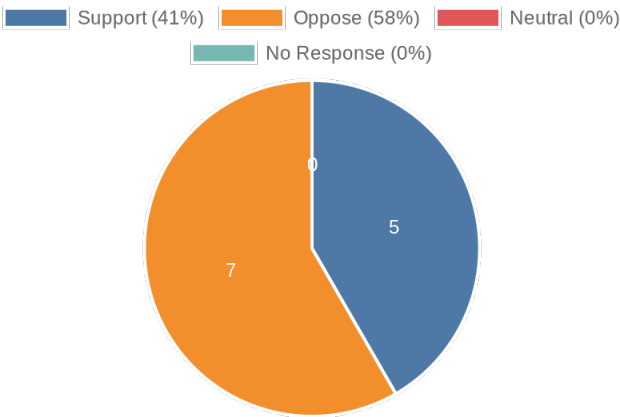

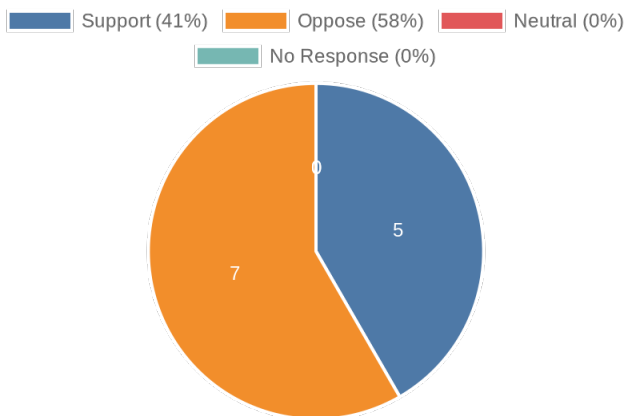

Voter ID laws are vital to protect the integrity of California's elections by ensuring only eligible voters cast ballots,

bolstering public trust, and minimizing fraud risks. California's reliance on signature verification at polls is vulnerable to errors or forgery. Requiring photo ID, standard for MANY secure transactions, would strengthen safeguards. A 2021 Rasmussen Reports poll indicated 75% of Californians support voter ID laws, reflecting demand for measures to enhance confidence in election outcomes, particularly after 2020's disputes. While some may cite "access barriers," California already mandates ID for certain first-time voters under the 2002 Help America Vote Act, and free IDs are available. Implementing ID checks at polls would reinforce election security, deter potential fraud, and uphold the democratic process. This is NOT some fringe position - this is a \*common sense\* move that is supported by nearly one third of America.

I strongly oppose legislation requiring voter ID at the polls. Voter identity is already verified during registration using a driver's license, state ID, or Social Security number, and studies show voter fraud is extremely rare. Nearly 21 million U.S. citizens lack a current driver's license, and 30 million more have licenses with outdated info (such as an old address) or no government-issued photo ID at all. These laws disproportionately harm young voters, Black and Hispanic communities, disabled individuals, and those with lower incomes or education, exacerbating inequities. Most voters in states with such laws are unaware of the requirements, leading to confusion and disenfranchisement. Voter ID laws create barriers to voting, discourage civic participation, and weaken democratic values. I urge the Board to prioritize policies that ensure equal access to voting for all

citizens, rather than imposing unnecessary restrictions.
