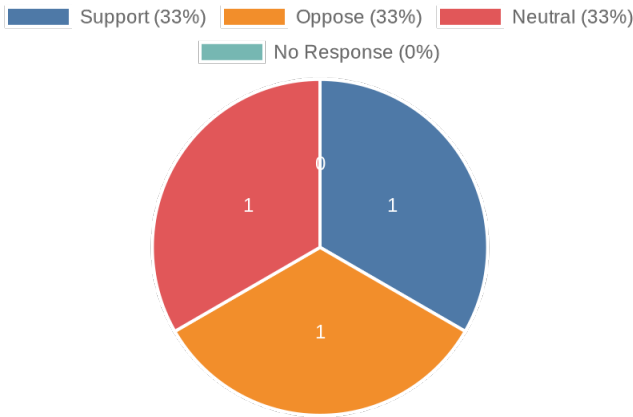

### Overall Sentiment

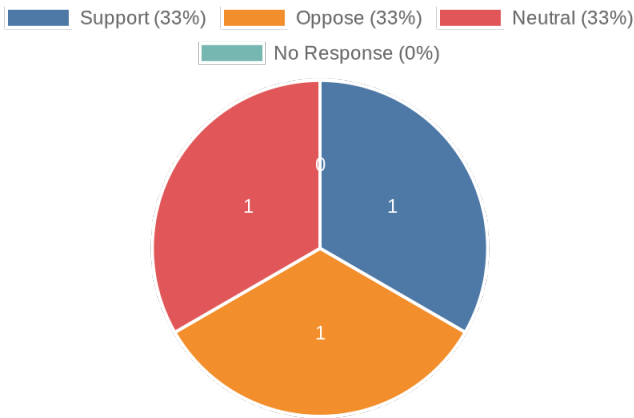

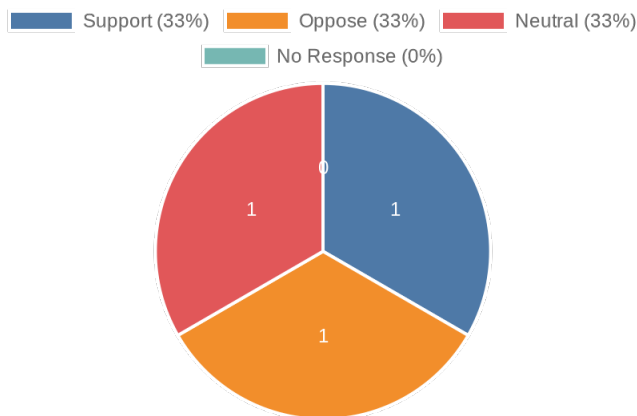

Let me guess – their old continuum failed so they need a new one, hopefully more inclusive of the entire County as we have suggested. But this is no change.

The Board letter mentions that the County needs about 400 beds. But then, the only hospital mentioned is in recommendation 2: “Direct the Chief Administrative Officer (CAO) to enter into discussions with Prime Healthcare to expand the number of behavioral health psychiatric acute inpatient beds available to people who are Medi-Cal eligible within Paradise Valley Hospital.” So, cram 400 beds here? But more concerning, restrict them to Medi-Cal eligibles when the problem is all over the County.
