SUMMARY OF PROPOSED ORDINANCE

Notice is Hereby Given that the Board of Supervisors of the County of San Diego will consider for adoption:

AN ORDINANCE AMENDING TITLE 7, DIVISION 3 AND AMENDING TITLE 4, DIVISION 2, CHAPTER 1 OF THE SAN DIEGO COUNTY CODE OF REGULATORY ORDINANCES, RELATING TO UNAUTHORIZED CAMPING AND PROTECTION OF OPEN SPACE AND PUBLIC WORKS FACILITIES

This ordinance will add property that is managed, but not owned or leased, by the County to existing areas where unlawful camping and maintaining an encampment are prohibited. It will add new prohibitions on making or maintaining fires, using or possessing ignition sources while camping, discarding combustible material, storing personal belongings or waste, and activities that alter public property such as digging or building structures. Enforcement of these prohibitions will require sufficient and appropriate shelter for all unhoused persons in the unincorporated area, except during an imminent threat to public health or safety. The ordinance will also make it unlawful to remain within closed public works areas during an emergency, construction, or maintenance.

The proposed ordinance will be presented to the Board of Supervisors for the first reading on **May 6, 2025** at which time public testimony will be received. The Board meets at 9 a.m., in Room 310, County Administration Center, 1600 Pacific Highway, San Diego, California.
