WHEREAS, pursuant to such notice, on June 25, 2025, a hearing was held on said report; and

WHEREAS, the Board of Supervisors has heard and considered all objections and protests to said report and to the fees and charges set forth therein.

NOW THEREFORE IT IS RESOLVED, DETERMINED AND ORDERED as follows:

- That protests or objection to said report to fees and charges set forth therein has not been made by owners of the majority of separate parcels of property described in said report.
- 2. That all objections and protests are overruled.
- 3. That said report, and each and every fee and charge set forth in said report, is hereby approved, affirmed and adopted.
- 4. That the Clerk of the Board file with the Auditor and Controller of the County of San Diego a copy of said report as approved, affirmed and adopted by the Board, together with a statement endorsed thereon over the clerk's signature that said report has been adopted by the Board.
