BOARD POLICY STATEMENTS:

Board Policy B-29 mandates that departments seek to recover the full cost, to the extent legally possible, of all services provided to agencies or individuals outside of the County of San Diego through grants, contracts or, where they may be charged fees. Reimbursement through grants, contracts or fees will be for the full cost of all services, with certain exceptions approved by the Board of Supervisors. A waiver of Board Policy B-29 is requested because the proposed fees will not cover the current operating costs for services in the ASA. The unrecovered cost, estimated at \$10.0 million, will be funded with existing General Purpose Revenue and property tax revenue.
