Hi Supervisors, Helen,

I looked at the budget and am glad to see that it does not begin with an award like last time I looked. Thank you. There are also many good things in it, especially the additional staff for detentions inspections by the Citizens' Law Enforcement Review Board and the increased focus on Mental Health and Substance Use Disorder, but some of the individual proposals are wasteful or really bad and harmful proposals. We can do better. Please be open to revising these in the final.

On another issue, the lack of a Board Member representing District 4 is highly problematic.

Mental Health and Substance Use Disorder

1. You want to spend \$8.8 million for 41 long-term beds. \$214,634 is a heck of a lot per bed, and not nearly enough beds anyway if you're serious about solving problem of raving addicts on the streets.

2. You want to spend \$18.3 million for implementation of the CARE Act, a new state program for people with serious behavioral health issues that may provide services, shelter and treatment through a civil court proceeding. Do we really need that much in the budget, or is there another source of funds, or do we need this much funding at all?

3. You want to spend \$7.1 million to address opioid addiction. However, increased awareness and enforcement seem to be making this problem better already. Do we really still need all these funds?

Homelessness and Housing

4. You want to spend a \$25 million increase for the Innovative Housing Trust Fund to help build affordable housing. Why not start where the real problem is - homeless housing, and rent them out as affordable units on the basis of need rather than designating them as affordable from the start. And we know where those units go - bought out by Blackstone and transitioned upscale.

5. You want to spend \$2.3 million for homeless services/housing for LGBTQIA+ community [why special housing for just these people - what about veterans, older people, disabled? Do we want to end the problem or kick the can down the road for those who are arguably worse off (and veterans are probably better equipped to help the community at large.) Plus, why single people out for help if they want to be part of the community as a whole - it creates feelings associated with exclusion, separateness, and yes - the whole neighbor vs. neighbor thing again and again. Wonder what causes it?

Sustainability and Fighting Climate Change

6. You want to spend \$3.8 million to continue work on an ambitious Regional Decarbonization Framework that will help communities move the region toward zero carbon emissions and plan to plant 5,000 trees as part of a regional effort to add 10,000 trees throughout the county to naturally remove carbon dioxide from the air and lower temperatures. We need a lot more than just decarbonization. Methane is worse in its effects than carbon dioxide. There are 8 major greenhouse gases. Going just to net zero will do little for the environment. A large proportion of newly planted trees die, BTW.

7. You mention "To reduce the County footprint and save costs by eliminating the need for a new facility, an office space consolidation plan is underway at the County Operations Center" Tinier cubicles - does this mean you're now

hiring smaller people?

Justice Reform

8. You want to spend \$2 million to keep young people out of the criminal justice system and address underlying causes of their harmful behavior [Does this include children driven nuts or who are keyed up and lash out because of radical teaching or policy (CRT, LGBTQ in inappropriate places, poor health (improper ventilation, etc.)]

9. You mention "Additional staff for detentions inspections by the Citizens' Law Enforcement Review Board, an independent body responsible for investigating complaints against San Diego County Sheriff's deputies and probation officers." How about additional staff for use-of-force investigations, such as Audra Morgan, who was beaten for her political action?

10. You mention additional staff to implement the cannabis business tax and a Social Equity Program to address the disproportionate harm caused by the War on Drugs on communities of color. Does this mean you want to spread the harm from a poorly planned tax scheme to the rest of the ? Or am I reading this wrong?

11. You mention Homeless Court Pop-Up Resource Fairs supported by County, City and homeless service agencies to help those at risk of or experiencing homelessness to resolve minor offenses. Does this mean that those who show up at these non-permanent pop-ups will have a better chance at getting their offenses resolved? - sounds rather discriminatory.

Investing in Working Families

12. You want 354 additional staff years across all Health and Human Services Agency

departments to support safety net programs like CalWORKs, CalFresh, and Medi-Cal, and services for behavioral health, public health, seniors, children, and families.

Based on its prior performance, particularly during COVID and wastewater testing, where it went for the one-size-fits-all mandates, lockdowns, and masking, and pretty much pushed the mRNA shot as if the only preventative measure, rather than focussing on the individual, I do not trust HHSA to support safety net programs without regular and public audits to build confidence that our money is being properly spent in a manner which respects the individual.

Healthy and Safe Communities

13. What about more funding to help students with a perverse education system where the administration and teacher no longer believe that all students are individuals but force-feed them controversial and wrong theories and instead dictate from the top down? When one teaches, two learn - I wish more people realized that teaching is really a two-way experience!

14. We also need more funding (as I said last meeting) for Child Care as more moms enter the workforce.

I'm sure that you are reviewing and correcting the budget documents. I think we can do better, and I hope my suggestions are helpful.
