

#### **Overall Sentiment**







In 2024, ICE detained over 100,000 immigrants with criminal convictions, including 12,000 for violent crimes like assault or robbery, per DHS data. Non-cooperation by sanctuary cities can shield these offenders, risking further crimes; a 2017 DOJ report linked 40% of repeat offenses in some areas to lax local policies. Collaboration ensures swift removal of verified threats, deterring illegal re-entry—ICE reported 15,000 re-entry arrests in 2023. Critics might argue it erodes trust in communities, but ICE's Secure Communities program prioritizes SERIOUS OFFENDERS, not minor violations. Cooperation streamlines enforcement, reduces local costs, and reinforces legal accountability. And, a February 2025 poll showed 89% support deporting undocumented immigrants with criminal convictions. This is a common sense view that is being fear mongered by critics.
