SUBJECT: Item 22: Rural Health Post-Hospital Discharge Pilot Program Report —
Sharp HealthCare Support

Dear Chair Vargas & Supervisors,

Sharp HealthCare (“Sharp”) is proud to support the Rural Health Post-Hospital Discharge Pilot program, which has resulted in improved patient outcomes and recovery after a hospital stay. Sharp urges the Board of Supervisors to continue providing these important support services for patients by reauthorizing the Rural Health Post-Hospital Discharge program.

Over the last year, Sharp Grossmont Hospital (SGH) has proudly served as the hospital partner for this pilot program, identifying eligible patients and referring them to the program for further services and support. Patient participants then receive home visits from the program’s two-person outreach team of a County Public Health Nurse and County Paramedic who support patient recovery. The outreach team works with patients to reinforce post-discharge care directions, assess patients’ clinical and social needs, provide case management, refer patients to County programs and address issues around the patient’s home, including social determinants of health. In addition, SGH supplies disease-specific patient care kits that are delivered by the public health nurse during the initial home visit. These kits support, educate and empower the patient in their post-discharge healing journey.

The County report features the quantitative data and program effectiveness based on fewer readmissions data - among patients participating in Rural Health Post-Hospital Discharge Pilot, only 4.0% were readmitted to the hospital within 30 days of discharge, while 13.9% of patients who declined participation in the program had to be readmitted to the hospital.

But the program’s success is just as clear when looking at the quantitative outcomes. The outreach team reported marked improvement in patient outlook, positivity and personal empowerment and ownership in their health over the course of the visits.
