The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.161.25.6. of the San Diego County Code is hereby added:

SEC. 72.161.25.6. VALLEY CENTER. The prima facie speed limit on Mirar de Valle Road from the west line of Valley Center Road westerly to the east line of Cypress Ridge (private road) is hereby decreased and established at 45 miles per hour.

Section 72.169.19.6. of the San Diego County Code is hereby added:

SEC. 72.169.19.6. JAMUL. The prima facie speed limit on Lawson Valley Road from the north line Skyline Truck Trail easterly to the end of County maintenance (at Rudnick Drive) is hereby decreased to and established at 35 miles per hour.

Section 72.169.45.1. of the San Diego County Code is hereby added:

SEC. 72.169.45.1. LAKESIDE. The prima facie speed limit on El Monte Road from the north line of Lake Jennings Park Road easterly to the El Capitan Reservoir Gate is hereby decreased to and established at 40 miles per hour.

Section 72.161.18. of the San Diego County Code is hereby amended:

The prima facie speed limit on Highway 8 Eight Business (County Road F58) from the easterly limits of the City of El Cajon (east of Lavalala Lane) easterly to the west line of Lake Jennings Park Road ~~(County Road E32)~~ westerly to ~~the easterly limits of the City of El Cajon~~ is hereby decreased to and established at ~~50~~ 40 miles per hour.
