





I am neutral on this because, while it makes sense that unincorporated San Diego County should have representation on SANDAG Board of Directors, the Board uses an undemocratic tally vote (ie, unweighted vote), which suppresses the voices of the citizens of San Diego (>40% of the County population) and Chula Vista significantly. AB 805 (2017) passed so that a weighted vote of the Board could be taken, which gives proportional representation to all cities; however, the Board refuses to use the weighted vote on important matters (eg 2025 Regional Plan). Small suburban communities in the county, eg Del Mar with 3900 residents, have vastly outsized voting power. This hurts San Diego and Chula Vista, and the result is, insufficient resources for better bus and rail transit systems, and 93 miles of highway expansion over the next 10 years (\$2.3B) that won't ultimately reduce congestion but will greatly increase greenhouse gas emissions.
