

Overall Sentiment







In July 2018, a wind-driven grass & brush fueled wildfire broke out on I-5 corridor in Henley-Hornbrook CA. The deadly Klamathon Fire raced over privately-owned, state & federally owned landscape choked with grass & brush (where our cultural-heritage wild horses did not graze), & headed towards the old growth forest (Cascade-Siskiyou Monument) & the college town of Ashland Oregon, which was placed on 'standby' for immediate evacuation.

By the time the wildfire reached landscapes managed by horses, it had already incinerated 38,000-acres of primarily grass & brush. But once it reached huge fire-breaks grazed-in by horses, the fire lost ferocity. CALFIRE stopped that wildfire in the immediate area where horses created 1k acre fire breaks! I know because I was on the fire-line for 9 days. Some scientists call that a 'proof'. Unlike ruminant Goats & Cows, horses do not digest the seeds of plants & grasses needed for soils stability to prevent erosion. Horses also provide tourism
