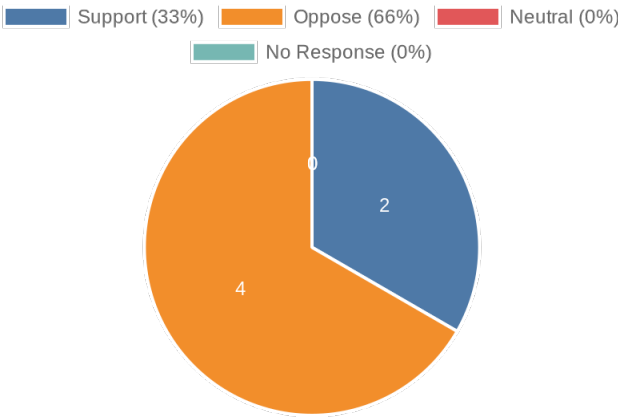

Overall Sentiment

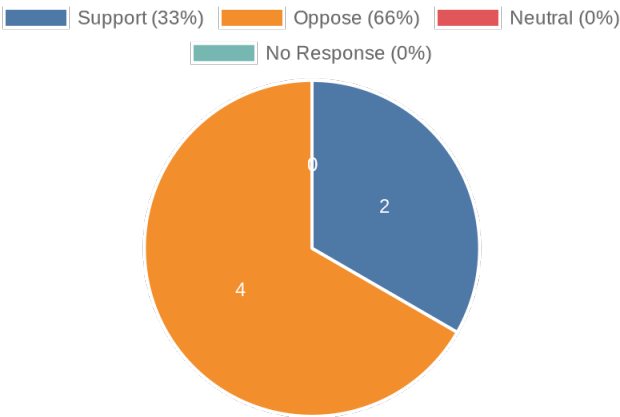

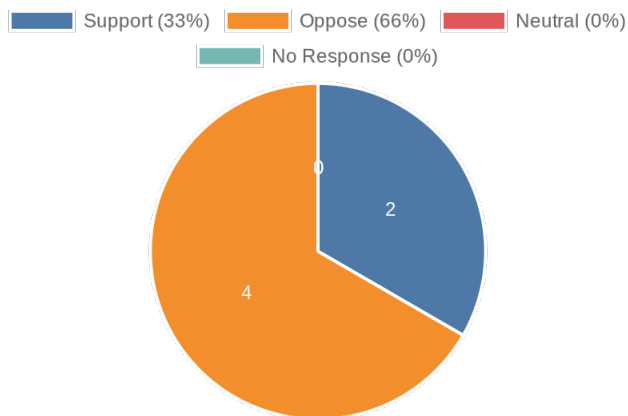
