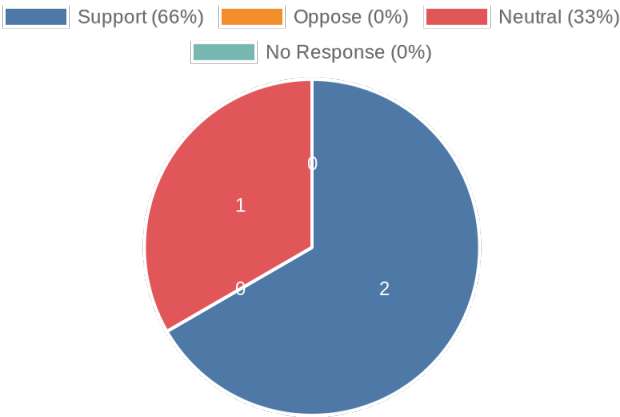

#### Overall Sentiment

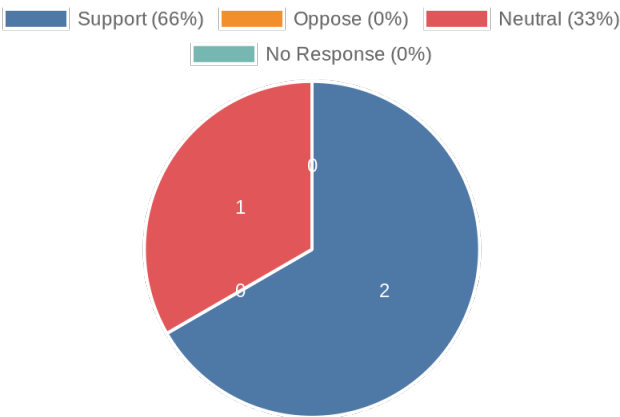

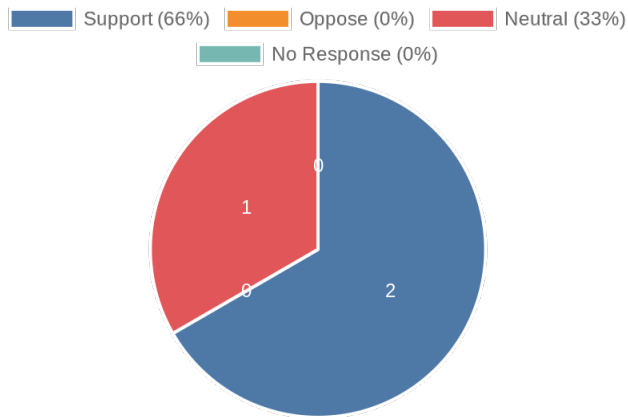

I support Supervisor Montgomery Steppe's proposal to allow the board to follow the State Law's "two-step process" which gives the board the flexibility to hold public budget hearings and adopt the final budget no later than Oct 2. District 1 is the most diverse district in the county. We saw firsthand what happens when budgets are passed with a supervisor seat vacant -- community members in that district have no say and get left out of the budget process.
