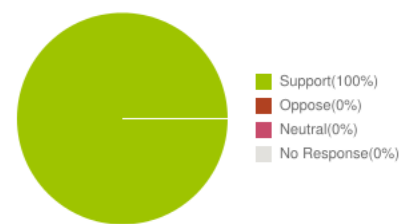

Overall Sentiment



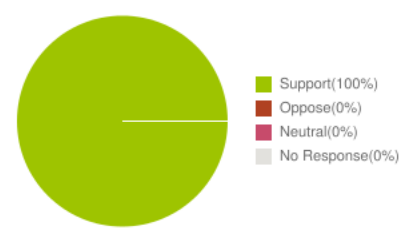

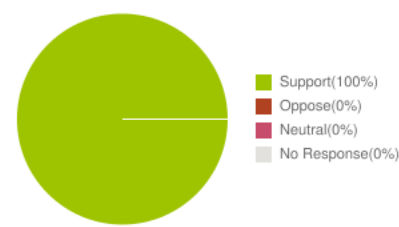
