# San Diego County Supervisors,

My name is Joe Salgado, and I am a 30-year retired military disabled veteran, recently retired from the federal work force supporting our activeduty military personnel and a homeowner in Lemon Grove Ca. I have been a resident in Lemon Grove since 1985. I was at the meeting presented by county representatives from district four on Thursday 18 July 2024 for the project to build homeless sleeping containers on Troy Street in Lemon Grove, at which 99.5% of the Lemon Grove residents that were present were in opposition with and do not agree with this location. My understanding is that a vote was taken on Tuesday 16 July 2024 and approved this project before it was even discussed with the residents that it will affect. Ms. Steppe district four county board of supervisors stated they talked with residents prior to voting on this project. Sticking a flyer in the door of someone's house the day after the vote was taken is not proper notification to residents of a proposed project. This tactic was unprofessional and deceptively done by the county after the homeless sleeping containers were disapproved by the residents of Spring Valley in a different location. I am not sure if the Lemon Grove Mayor or city council were fully aware of this proposal or had any say in it at the time. I requested the Lemon Grove Mayor and councilmembers get an injunction to stop this project from going any further until it can get properly vetted and hopefully rescinded. The Mayors of Lemon Grove both past and present have continually refused to put this issue on the agenda so it can at least be officially addressed. My understanding is that when Ms. Snow (at the time was a Lemon Grove city council member, now mayor) went to the county board of supervisors prior to their vote and stated Lemon Grove would be interested in this project without addressing this issue with the Lemon Grove residents.

My personnel opinions are that these types of projects do not help the homeless, are a waste of the taxpayer's money (when used) and often exacerbate the underlying problems for many of the people that are homeless.

If this project gets approved it will cause major safety issues and a drastic increase in theft, violent crimes, etc., in the adjacent neighborhood and community at large. This will increase the number of homeless people in Lemon Grove and Spring Valley, most of which were never members of this community and are from different areas, states & countries. This will significantly decrease the value of homes in this area which many of us work hard to pay for and live in a decent neighborhood. This location is near established schools and daycares that will put these children at risk. We are a blue-collar working community, not a rich area that can afford a gated community with 24-hour private security.

Sleeping containers are not the answer and have been a continued failure throughout the state! It does nothing to help with rehabilitation or addressing the truly underlying issues that drove many of these homeless people into their current situation. These sleeping encampments will endanger the safety and security of the surrounding neighborhoods and schools and increase local crime rates.

If elected politicians are going to continue to push these type projects, weather it is for lucrative contracts for their associates/friends, political points etc.; they should select a location that is away from residential neighborhoods and schools and that provide mandatory proper medical or counseling support for the people that require the help. The eleven million dollars (plus) and cost to maintain this encampment would be better used for inpatient facilities that have 3–6-month programs to address the root cause(s) on why they are homeless along with a plan to better themselves and become a productive member of society.

Due to the different issues like mental illness and drug/alcohol addiction, many of the homeless will not voluntarily enter a program. We need to go back to the tough love process to get these people into a treatment program for the help they desperately need.

This just appears to be another money grab from the state, by local politicians so they can squander the funds on their personal pet projects. In the

last three years our state has invested over twenty-four billion taxpayer's dollars to address the homeless situation with nothing to show for it!

We have had numerous petitions from residents and local businesses opposing this project (one of which over 430 residents signed in less than 96 hours opposing this project) and all appear to be ignored. If the state is eliminating homeless encampments on state land, I do not believe renting or selling CALTRANS property to the city of Lemon Grove or the county of San Diego to put a homeless encampment on is a legal or a valid approach. Your assistance in reviewing this location and rescinding the vote taken of 16 July 2024 would be appreciated. Please let me and the majority of Lemon Grove & Spring Valley residents that disapprove of this project know what is required to stop this travesty from proceeding.

Our community has experienced significant challenges in recent years, including a severe lack of transparency and communication regarding the Troy Street Project which is associated with this item. Placing it on the consent calendar only serves to exacerbate the existing distrust and prevents the necessary public engagement required for responsible governance. To begin the process of rebuilding trust and demonstrating a commitment to transparency, I ask that you allow the community the opportunity to hear the details of Item 11 presented on the floor and to exercise our right to speak on the matter during public comment. It is critical that the Council/Board hears the public comment and is fully informed of the project's real-world implications before making a final decision. I urge you to allow public comment that residents of Lemon Grove deserve.

I have lived in Lemon Grove for over 50 years and have seen significant changes to my community. When Allison Snow was running for Mayor of Lemon Grove, she came to my home while campaigning. I expressed my concerns with the condition of the City, the amount of empty buildings, homelessness, etc. I told her that while I would love to spend my money locally, but because of the state of the City, I do not shop or dine in Lemon Grove as I do not always feel safe. Ms. Snow assured me that she had a "plan". Two days later I found out that her plan is the Troy Street Project, which will be located near the end of my street! Had she told me this when we met, we could have had a conversation and many of my questions could have been answered. Instead I felt betrayed and railroaded into living next to a project that nobody in Lemon Grove knew anything about until it was a done deal. The City and the County have had meetings with the citizens, but it was clear from the meetings that the voices of the Lemon Grove citizens did not matter and would not be heard.

Instead of helping the local homeless population, you are taking unvetted individuals from other areas and putting them in "tiny homes" at the end of my street! I have not seen any solid information regarding how these individuals will be rehabilitated or placed into permanent housing. I have not seen any reassurances that our neighborhoods will remain safe. I have come across many of the mentally ill and drug addicted individuals throughout the City and, quite frankly, a tiny home will not cure their ills. Placing them into a neighborhood and near a preschool is downright reckless and will open the City and County up to lawsuits due to the actions of the unstable individuals you are putting into our community. Putting them in "sheds" is not humane. We must find other resources to help these individuals such as permanent housing, drug rehabilitation programs, and mental health programs. While I understand that homelessness is a serious and difficult issue to solve, the money spent on this project would be better used toward programs that actually help people get off the streets and into permanent housing and treatment, not just a box to sleep in with no plans. Everything about this project is wrong. It is the wrong location. It is the wrong solution. And it's wrong for our City.

I urge your vote to pull Item 11 from the agenda and allow the necessary public scrutiny that the citizens of Lemon Grove deserve.

It is a disgrace that this was placed on the Consent Agenda to begin with. The Board's Rules of Procedure state that all items on the Consent Agenda "are considered to be routine." Item 11 is NOT a routine item. It is a controversial, major policy decision that involves the decision to shift from a \$1-per-year lease to a \$2 million land sale. A "no" vote on this item could result in the cancellation of a \$13 million project, while a "yes" vote would lead the County down a path where the project budget grows beyond \$15 million. There is nothing routine about that choice.

Leaving Item 11 on the Consent Agenda would be an abuse of the Board's discretion and a violation of the spirit of the Brown Act. I would appreciate a response and confirmation prior to the Board meeting that this item will be pulled from the Consent Agenda and provided a full hearing and discussion by the Board.
