This ordinance will adopt the 2025 Local Responsibility Areas Fire Hazard Severity zones in the Ramona, Borrego Springs, Desert, and Mountain Empire Areas. Said proposed ordinance will be presented to the Board of Supervisors for the first reading on June 24, 2025, at which time the Board will be asked to approve the introduction of the Ordinance (first reading) and, if approved, then on August 26, 2025, the Board will consider and adopt the Ordinance (second reading). If the proposed ordinance is altered on August 26, 2025, then on that date a subsequent meeting date will be selected for the ordinance's adoption.


