

## Libi Uremovic



The Agencies under State and Federal investigation for operating a cradle to grave human trafficking operation are the San Diego County Sheriff, Foster Care, Department of Education, District Attorney's Office, and of course the San Diego County Supervisors that have facilitated, financed, and covered up the torture and abuse of children for many years.

State and Federal Laws allow Elected and Appointed officials to make honest mistakes, but they are Civilly and Criminally responsible for their criminal activity.

Gang-Beatings of children by the Guards violates a multitude of State and Federal laws and the Geneva Convention.

Shower Water Turned to Freezing/Boiling, which is a recognized form of torture by the Geneva Convention.

Stealing U.S. Mail in violation of United States Penal Code 530.5(e).

Denied Right to Brush Teeth in Violation of Title 15 Sections 1485 through Section 1488, 8th Amendment, and Geneva Convention.

Starvation as a form of punishment in violation of California State Law, U.S. Federal Law, and Geneva Convention.

Stealing Kids' Personal Items in violation of Title 15, Section 1360 and the 4th Amendment to the U.S. Constitution.

"Keep your mouth shut or you'll be fired" is the open policy within the San Diego Department of Education, that operates the education system in the kids' jails.

Housing Foster Kids in Jail in violation of State and Federal Foster Care Laws.

No Bail for minors in violation of U.S. Constitution Eight Amendment. San Diego holds kids in jail until they 'confess' - usually to crimes they didn't commit.

Failure to Report Child Abuse. Every Judge, Public Defender, and District Attorney working with children are mandated reporters. When they children tell their public defenders or judges about the torture and abuse they suffer in jail every mandated reporter adult from the San Diego County Courts have the same response: "What did you do to deserve it?"

The answer is - there is nothing a child can do to 'deserve' to be tortured and abused by the adults paid with taxpayers' money to protect them.

2025.08.26 Public Comment Board of Supervisors

Good Morning,

For the past six in a half months the community of Lincoln Acres has experienced taxation without representation in District 1.

Per Policy # I-1, the unincorporated community of Lincoln Acres, is seeking formation of a Community Sponsor/Planning Group designation from this Board of Supervisors. It is vital for this disadvantaged unincorporated community to have linkage with County on matters dealing with planning and land use. History has proven that our disadvantaged unincorporated community has been without a voice on matters relating to annexations, and development that has negatively impacted our neighborhoods.

Supervisor Aguirre, you attended our Lincoln Acres Civic Association meeting, I brought to your attention the need Lincoln Acres has to form a sponsor group or planning group and you were surprised one did not exist. I asked if you would support our community in forming one and you said that you would. I am here along with my neighbors, to formally go on record to seek designation of a Sponsor Planning Group for the community of Lincoln Acres, we look forward to hearing from you and your staff. My contact information has been left with the clerk.

Lincoln Acres has a great need for this. For example, late last year there was an irresponsible development that was proposed in an adjacent incorporated community. An established residential neighborhood in the unincorporated community of Lincoln Acres worked together to oppose a public health nuisance project. We need to establish this linkage so Lincoln Acres will have a voice as the General Plan states "LU-1.5 Relationship of County Land Use designations with the Adjoining Jurisdictions. Prohibit the use of established or planned land use patterns in nearby or adjacent jurisdictions as the primary precedent or

jurisdictions for adjusting land use designations of unincorporated county lands. Coordinate with adjacent cities to ensure that land use designations are consistent with existing and planned infrastructure capacities and capabilities."

"LU-4.2 Review of Impacts of Projects in Adjoining Jurisdictions.
Review, comment, and coordinate when appropriate on plans, projects, and proposals of overlapping or neighboring agencies to ensure compatibility with the county's general plan and that adjacent communities are not adversely impacted."

"LU-4.5 Annexations with incompatible land uses coordinate with LAFCO to oppose annexations by neighboring cities that would result in land uses incompatible with unincorporated lands."

LAFCO is responsible for coordinating directing and overseeing annexations of territory a prerequisite for annexation is the inclusion of a territory within an adjacent cities sphere of influence.

These named policies are viable reasons for the need for a Sponsor Planning Group for the disadvantaged unincorporated community of Lincoln Acres.

Currently, there are two community planning groups in District 1:

- 1) Sweetwater Community Planning Group
- 2) Spring Valley Community Planning Group

Denying Lincoln Acres a Community Sponsor/Planning Group would be geographically discriminating against the residents.

Approving the formation of Community Sponsor/Planning Group for Lincoln Acres would provide the residents with badly needed linkage with County on matters dealing with planning and land use.
