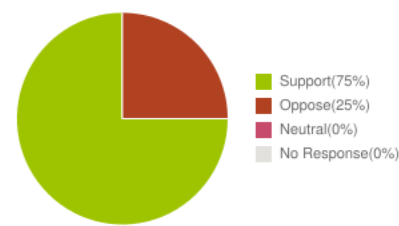

Overall Sentiment



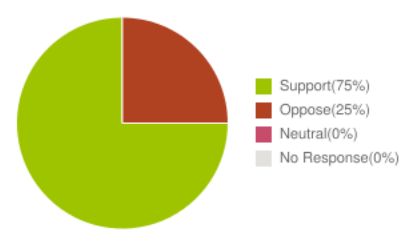

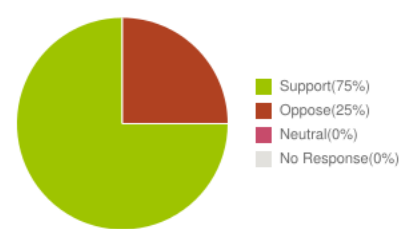
