

## **BOARD POLICY STATEMENTS:**

A single source contract for the procurement of Incredible Years Outpatient Behavioral Health Services Program is



being requested with Vista Hill Foundation. This provider qualifies for a single source contract based on the following section of Board Policy A-87 Competitive Procurement, Section 1D-4: A service provider has an exclusive agreement with the supplier and no other entity may provide the services. Vista Hill Foundation has been selected by the Escondido, Oceanside and Vista School Districts to provide school-based mental health services and has established agreements for services with the school districts. This collaboration and partnership between Behavioral Health Services and school districts has resulted in significant expansion of behavioral health school-based services where the contractors possess expertise, competencies, resources, and a partnership with the school district that cannot be replicated.

Additionally, a single source contract for the procurement of Mental Health Services Information System is being requested with ELLKAY, LLC (ELLKAY). This provider qualifies for a single source contract based on the following section of Board Policy A-87 Competitive Procurement, Section 1D-6: The procurement is for services where continuity of providers will provide efficiency or critical knowledge. Procuring ELLKAY's services ensures the long-term preservation and accessibility of patient data, providing retention for legal and regulatory compliance, reporting needs and support of ongoing patient care. The EHR contractor has informed the County that they will be sunsetting their agreement with ELLKAY. Therefore, to ensure the long-term preservation and accessibility of patient data, it is required we contract directly with ELLKAY. By ensuring continuity with the same provider, data migration between different systems within their platform becomes more streamlined and less complex. Furthermore, users are already trained in the interface and functionality of the provider's archive, making access and navigation more efficient. Moving to an alternate provider represents a risk of loss of data, as well as delays in productivity as staff will need to be trained on new systems. There are also additional financial costs to incur with the introduction of a new system, such as implementation fees and other associated costs.

A waiver of Board Policy B-29 is requested for Agreements with California counties because the funding does not offset all costs due to the 25 percent local match requirement of approximately \$198,334 in FY 2024-25 and \$595,000 in FY 2025-26. The funding source for these costs is existing Realignment. The public benefit for providing these services far outweighs these costs.
