

Dear Chairwoman Vargas and Honorable Members of the Board,

The undersigned 20 organizations represent the critical local infrastructure that our County relies on to address the urgent needs of migrants, serving as legal service providers, immigrants' rights advocates, policy organizations, and direct service providers. We write to you today with a renewed sense of urgency regarding the County's ongoing lack of progress in addressing the needs of migrants and asylum seekers in our region. Despite repeated calls for action over the past three years, the County remains far from where it needs to be in developing a robust, sustainable, and equitable response to this humanitarian challenge.

Many of us attended the County staff convened call on 12/4 where County staff shared their plan. We believe that creating a space for long-range thinking, planning, and coordination where all stakeholders take a shared responsibility for addressing this ongoing challenge would be more effective than a fragmented approach which neglects the broader need for sustained, region-wide solutions. **We strongly recommend the establishment of a County-convened task-force led by a regional facilitator from philanthropy and who is not a service provider. This approach would ensure the necessary flexibility and impartiality to effectively convene and coordinate stakeholders, fostering a collaborative and equitable regional response.**

As a border region, San Diego County will continue to receive individuals and families fleeing violence, persecution, climate crises, and systemic oppression. This reality demands a regional approach and networked response that is convened and facilitated by County leadership. We call on the County to meet this responsibility with dignity and compassion by implementing the following key actions:

1. **Hire a Director for the Office of Immigrant and Refugee Affairs**

Hire a director to oversee and coordinate the County's immigrant and refugee affairs and provide the direction necessary for this position to convene partners and implement long-term solutions.

2. **Develop a County Convened Regional Migrant Welcome Network to Develop Welcoming Infrastructure**

Essential elements of welcoming infrastructure, as highlighted in prior public comments and letters, include housing, culturally and linguistically competent case management and legal services, transportation, and trauma-informed services. The County must center and collaboratively work with impacted communities and nonprofit partners incorporating lessons learned from organizations already working on the ground. It must also select and fund a facilitator that is not a service provider with the flexibility and impartiality to effectively convene and coordinate stakeholders.

**3. Dedicated Staff and Regular Meetings**

A sustainable welcoming infrastructure requires dedicated County staff and regularly scheduled convenings with local community-based organizations, philanthropic partners, and other stakeholders. These meetings must focus on building capacity, ensuring alignment with community needs, and fostering collaboration.

**4. Commit to a Timeline for Progress**

We request that the County bring back a detailed plan co-developed by the Regional Migrant Welcome Network within 6 months for further development, including clear steps to operationalize these recommendations.

The County must acknowledge that regardless of changes in federal funding, administration, or border dynamics, the humanitarian need persists. Failure to act risks perpetuating systemic inequities and undermining the health and safety of migrants and our broader community. For years, community members have asked for a regional solution. Yet, despite repeated advocacy, there has been little progress.

We must ask: What is the County's plan? What are staff doing to address this ongoing matter? Do you intend to prepare for the future, or is the assumption that there will be no more migrants or asylum seekers?

San Diego County has the opportunity to lead with bold vision and moral clarity by investing in our local capacity and communities. The County's commitment to equity, sustainability, and collaboration must extend to all who seek refuge here. We urge you to act decisively to ensure that our region remains a beacon of hope for those in need.

Thank you for your attention to this critical issue. We look forward to your response and to working together to uphold our humanitarian obligation.

## **Memo on Migrant Welcome Infrastructure Planning in SD**

**December 4, 2024**

### **Action:**

1. Allocate \$2 Million to a County convened regional Regional Migrant Welcome Network that will work collaboratively to establish a formal and coordinated regional infrastructure and process for migrant welcome<sup>1</sup>.
2. Catalyst of San Diego and Imperial Counties will act as the fiscal recipient of funds<sup>2</sup> and convene nonprofit partners from January 2025 through 2026.
3. Direct CAO or designee to participate in the Regional Migrant Welcome Network to provide coordination and champion role for infrastructure efforts and intergovernmental affairs.
4. Pass an initial plan with a date to review in 180 days.

**Justification.** A coordinated and networked response convened by the county creates a streamlined and efficient system that can respond to fluctuating numbers of asylum seekers, builds capacity for effective County response to future challenges, and accomplishes the following:

1. Humanitarian obligation. San Diego County recognizes its legal and moral responsibility to provide compassionate care for individuals seeking asylum, consistent with international agreements such as the 1951 Refugee Convention and the U.S. Refugee Act of 1980. By ensuring access to temporary shelter, health screenings, and transportation, San Diego County upholds its commitment to human dignity, equity, and inclusion, reflecting its values as a welcoming region dedicated to supporting those fleeing persecution and seeking a safe haven.
2. Economic efficiency and ability to draw down federal dollars. By leveraging federal resources, such as the Emergency Food and Shelter Program, San Diego County demonstrates its commitment to fiscal responsibility and community stewardship. Collaborating with non-profit organizations ensures cost-effective service delivery, reduces duplication of efforts, and maximizes resources, reflecting the County's values of innovation, equity, and partnership in addressing the needs of migrants and asylum seekers.
3. Strengthens regional collaboration and community partnerships. This collaborative approach creates a formal and accountable structure that will enable San Diego County to manage the influx of migrants and asylum seekers effectively, ensuring their immediate needs are met while facilitating their transition to longer-term accommodations or final destinations. A county-convened Regional Migrant Welcome Network would provide an effective structure to engage impacted regional stakeholders such as the San Diego County Regional Airport Authority, San Diego Metropolitan Transit System (MTS), Taxicab administrations and others to facilitate onward travel for asylum seekers and address challenges as they arise.

Supv. Desmond asked us to comment on your proposed regulation, rule, law (whatever) to refuse cooperation with ICE, the Border Patrol, and other federal law enforcement officers dealing with offending illegal aliens. I am a veteran of 26+ years as an FBI Special Agent, and then I worked another 16 years with the FBI and the U.S. Dept of Labor to remove members of La Cosa Nostra from a labor union's ranks. My speciality was always organized crime. I am not writing to denigrate local law enforcement, but I know that its members do not have the ability to receive, analyze and act on the raw intelligence data federal agencies routinely accumulate on criminal gangs. If you prevent San Diego County law enforcement from working with federal partners, you run the huge risk of having us, who depend on you to secure our safety to the best of your abilities, victimized by criminal illegal aliens. President Trump is pledging to rid our country, and that means here, of criminal aliens first. Protecting them only adds to our costs and endangers us. In my service, I never mishandled, hurt, abused or killed any person under arrest, and I never saw any federal law enforcement officer do these things either. Our goal was always the safety of innocent persons in our society. We rendered criminal suspects unable to commit more crimes until they were identified and their crimes stated as a matter of fact. If there was no evidence against them, they were released, and promptly. We had only 48 hours to charge someone or let them go, and even the length of that time was dependent on their identifying themselves, or us doing so. You have a distorted view of how criminals are handled by federal and local law enforcement, and I would certainly be willing to take on an educational trip. Please, do not enact the foolish, destructive policy one of you has proposed. 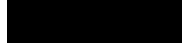

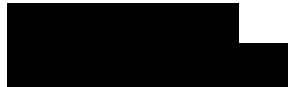
