B-29 Fees, Grants, Revenue Contracts - Department Responsibility for Cost Recovery; Section 401, Article XXIII of the County Administrative Code.

BOARD POLICY STATEMENTS:

Waiver of Board Policy B-29 is requested because the Health Resources and Services Administration revenues do not fully offset all costs. Costs to be waived for Ryan White Treatment Extension Act (RWTEA) Part A and Part A Minority AIDS Initiative are estimated to be \$75,859 for Fiscal Year 2024-25, \$231,371 for Fiscal Year 2025-26 and \$717,440 for the term of the grant. The public benefit for providing these services far outweighs these costs. RWTEA Part A fills an important gap in the local HIV service delivery system by ensuring individuals with HIV have access to high quality HIV primary care. The Deputy Chief Administrative Officer of the Health and Human Services Agency, certifies that these activities would be worthy of funding with County resources if external financing were unavailable.

Costs to be waived for Ending the HIV Epidemic are estimated to be \$30,195 for Fiscal Year 2024-25, \$90,584 for Fiscal Year 2025-26 and \$452,918 for the term of the grant. The public benefit for providing these services far outweighs these costs. RWTEA Part A fills an important gap in the local HIV service delivery system by ensuring individuals with HIV have access to high quality HIV primary care.
