

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO
CERTIFYING THE “URGENT NEEDS” NATIONAL OBJECTIVE IS BEING MET IN THE
APPLICATION FOR FUNDING FROM THE CDBG-DR AND MIT PROGRAMS

WHEREAS, County staff has reviewed the State of California’s Community Development Block Grant – Disaster Recovery (CDBG- DR) Action Plan for 2018 and determined that certain projects can be awarded by the County in accordance with the CDBG-DR and CDBG-MIT Programs;

WHEREAS, in order to qualify for CDBG-DR and CDBG-MIT funding the County must meet certain funding objectives or demonstrate an “Urgent Need” for the project in a manner consistent with federal funding requirements;

WHEREAS, the County may be required to provide a certified copy of a resolution which authorizes submission of projects under the “Urgent Needs” national objective to qualify for CDBG-DR and CDBG-MIT funding.

BE IT RESOLVED by the Board of Supervisors of the County of San Diego as follows:

- A. The Board authorizes the County of San Diego, Department of Public Works application submittal for a Community Development Block Grant – Disaster Recovery (CDBG-DR) and Mitigation (CDBG-MIT) grant from the California Department of Housing and Community Development – for Pecan Park Lane Erosion Repair Project and Estrella Drive Drainage Improvement Project under the national objective of “Urgent Needs”.
- B. The Board certifies that Pecan Park Lane Erosion Repair Project and Estrella Drive Drainage Improvement Project for which CDBG funds are being requested meets the “Urgent Needs” criteria because:
 - 1) They are designed to alleviate existing conditions which pose a serious and immediate threat to the health and welfare to the citizens of the County of San Diego by halting erosion that is currently approaching residential properties and maintaining integrity of a public road, respectively;
 - 2) The projects are needed to address conditions which are of recent origin or which recently became urgent during and immediately following the 2024 disaster(s) because the projects will repair a failing slope and replace a failing culvert, respectively;
 - 3) Neither the County nor the Flood Control District therein is able to finance the activity on its own, and that other funds that may otherwise be available are obligated for other critical issues.
