**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO  
DECLARING THE RESULTS OF THE NOVEMBER 5, 2024 STATEWIDE GENERAL  
ELECTION RELATING TO COUNTY OF SAN DIEGO OFFICES AND MEASURES.**

WHEREAS, pursuant to the provisions of Chapter 1 (commencing with Section 1000) of Division 1 of the Elections Code and Chapter 5 (commencing with Section 24200) of Title 3, Division 2 of the Government Code, and Articles IV and VI of the Charter of the County of San Diego, a statewide general election was held and conducted on November 5, 2024, during which the electors of the County of San Diego elected persons to fill the offices of San Diego County Supervisor – 1st District, 2nd District, and 3rd District; and

WHEREAS, pursuant to the provisions of Chapter 2 (commencing with Section 9100) of Division 9 of the Elections Code, the Board of Supervisors, by Resolution, proposed a measure designated as Measure G to the electors of San Diego County on November 5, 2024; and

WHEREAS, said election was conducted on November 5, 2024 in the manner required by law and the proposed measure, designated Measure G on the ballot, was submitted to the electors for approval or rejection; and

WHEREAS, on December 5, 2024, the Registrar of Voters of the County of San Diego certified to the Clerk of the Board of Supervisors the results of the canvass of said election;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED that the results of said regular general election are as follows:

COUNTY OF SAN DIEGO SUPERVISOR – 3 <sup>rd</sup> DISTRICT		
Terra Lawson-Remer	178,781	56.98%
Kevin L. Faulconer	134,991	43.02%

**MEASURE G: PROPOSED “FUND SAN DIEGO COUNTY TRANSPORTATION, INFRASTRUCTURE, AND SAFETY PROJECTS THROUGH A HALF-CENT SALES TAX”**

To repair/upgrade roads, bridges, storm drains, rail lines, and prevent railway bluff collapse; reduce traffic congestion; improve pedestrian, bicyclist, and driver safety; improve public transit; protect wildlife habitat/air quality; and fill potholes; shall the measure authorizing a half-cent sales tax raising \$350,000,000 annually until ended by voters, requiring citizen oversight, public spending disclosure, and independent annual audits be adopted?

IT IS FURTHER RESOLVED, DETERMINED, AND ORDERED that more than a majority of the electors voting for the office of the Board of Supervisors – District 1 at said statewide general election have voted in favor of Nora Vargas, and, therefore, Nora Vargas is hereby declared elected to the office of Board of Supervisors – District 1.

IT IS FURTHER RESOLVED, DETERMINED, AND ORDERED that more than a majority of the electors voting for the office of the Board of Supervisors – District 2 at said statewide general election have voted in favor of Joel Anderson, and, therefore, Joel Anderson is hereby declared elected to the office of Board of Supervisors – District 2.

IT IS FURTHER RESOLVED, DETERMINED, AND ORDERED that more than a majority of the electors voting for the office of the Board of Supervisors – District 3 at said statewide general election have voted in favor of Terra Lawson-Remer, and, therefore, Terra Lawson-Remer is hereby declared elected to the office of Board of Supervisors – District 3.

IT IS FURTHER RESOLVED, DETERMINED, AND ORDERED that more than a majority of the electors voted against Measure G and, therefore, said measure failed.
