ORDINANCE ADDING SECTION 72.169.8.4., AMENDING SECTIONS 72.161.9., 72.169.54., AND 72.169.58., AND DELETING SECTIONS 72.161.9.1., AND 72.169.75. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.8.4. of the San Diego County Code is hereby added:

SEC. 72.169.8.4. FALLBROOK. The prima facie speed limit on Rainbow Heights Road from the east line of Rice Canyon Road easterly to the end of County maintenance (Sombrero, private road) is hereby decreased to and established at 30 miles per hour.

Section 72.161.9. of the San Diego County Code is hereby amended:

SEC. 72.161.9. RANCHO SANTA FE. The prima facie speed limit on Rambla de las Flores from the south line of La Granada (~~County Road A23~~) southerly to the west ~~north~~ line of Línea del Cielo La Orilla is hereby decreased to and established at 35 40 miles per hour.

Section 72.169.54. of the San Diego County Code is hereby amended:

SEC. 72.169.54. FALLBROOK. The prima facie speed limit on Stage Coach Lane from the east line of Mission Road (~~County Road H53B~~) to the south line of Fallbrook Street a point 1580 feet south of the south line of Calavo Road is hereby decreased to and established at 40 miles per hour.

Section 72.169.58. of the San Diego County Code is hereby amended:

SEC. 72.169.58. FALLBROOK. The prima facie speed limit on Stage Coach Lane from the north line of Fallbrook Street a point 1580 feet south of the south line of Calavo Road to the south line of Mission Reche Road is hereby decreased to and established at 35 45 miles per hour.

Section 72.161.9.1. of the San Diego County Code is hereby deleted:

~~SEC. 72.161.9.1. RANCHO SANTA FE. The prima facie speed limit on Rambla de las Flores between La Orilla and Linea del Cielo (a distance of 1.05 miles) is hereby decreased to and established at 40 miles per hour.~~

Section 72.169.75. of the San Diego County Code is hereby deleted:

~~SEC. 72.169.75. FALLBROOK. The prima facie speed limit on Stage Coach Lane (County Road H22) between the south line of Mission Road (County Road H53B) and the north line of Reche Road (County Road H30) is hereby decreased to and established at 40 miles per hour.~~
