The Board litter-Letter says this County has taken aggressive action removing three times more illegal firearms from our streets. I'm sure it's a big number, but three times more than WHAT?

It says research from Brady United found that 90 California law enforcement agencies purchased firearms from dealers with documented violations against gun regulations. Doesn't say what the violations were - a signature missing or an actual sale to a felon - or where the actual sale was. Maybe these people are buying guns in another County? **This is a due process issue, Terra, not a Gun Control issue.**

Much of the info. Is already recorded and law enforcement has it. Re-creating it would affect the running and profitability of the business.

DBA EQUUS WORKFORCE SOLUTIONS (CONTRACT #564750)

EQUUS has been horrible, not understanding, not patient, and needs to be audited. It might be good enough for Kentucky, where it is based, but its performance in San Diego is abysmal – different culture. That's what you get for going out of State for a service contract. Some work out. Most don't.

My understanding is that even while being serviced by EQUUS, several people had to pack up or move several times. If even one such is substantiated, this should also be included in the audit.

Since the rainy season is coming, and who knows what it will bring, it is past time that we do an audit which will undoubtedly find and fix flaws in the system.

Suggest you do a post-audit or checkout list for all County contractors.
