<p><b><i>Behavioral Health Collaborative Court</i></b>                      Collaborative court model providing clinical case management, mental health, substance use rehabilitation and recovery services to formerly incarcerated adults.</p>	<p><b>Justice-Involved</b></p>
<p><b><i>Behavioral Health Support Services</i></b>                      Onsite services and permanent supportive housing to adults residing at San Diego Housing Commission's housing developments with a mental and/or substance use condition.</p>	<p><b>Supports for clients at risk of or experiencing homelessness</b></p>
<p><b><i>Recuperative Services Treatment for Transition Age Youth</i></b>                      Services include short-term housing that incorporates innovative, recuperative, and habilitative housing and supportive services.</p>

<p><b>Bio-Psychosocial Rehabilitation Services</b> Treatment, rehabilitation, and recovery services to adults who have SMI, including those who may have co-occurring substance use conditions.</p>	<p><b>Mental health and/or co-occurring substance use services</b></p>
<p><b>Central Region Urgent Walk-In Program</b> Urgent mental health services consistent with psychosocial rehabilitation and recovery principles.</p>	
<p><b>Substance Use Outpatient Treatment Program</b> Regional recovery centers provide non-residential substance use treatment and recovery treatment.</p>
