

History and Changing Landscape



2001 - Opened on 238 acres as the first residential education campus in the U.S. designed for foster youth.

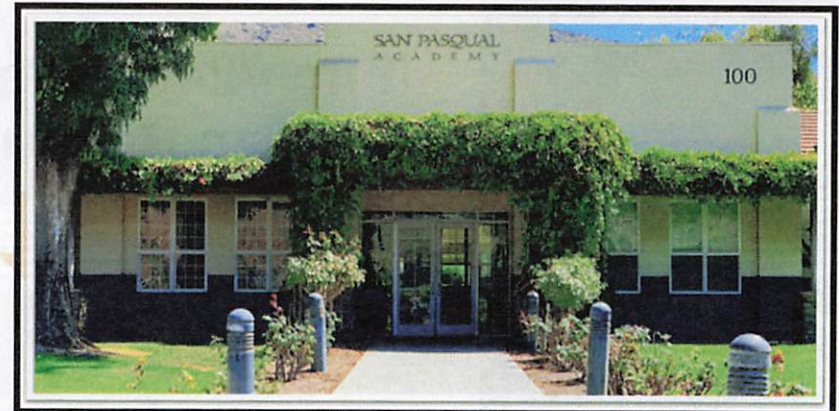
Legislative Reform Impact: Prioritized placement in family-based settings.

- **2015** - Continuum of Care Reform (CCR)
- **2018** - The Family First Prevention Services Act (FFPSA)

2021 - State determined San Pasqual Academy educational residential program did not meet CCR and FFPSA foster care requirements.

2022 - The Board approved actions to transform San Pasqual Academy into a continuum of care, multipurpose campus.

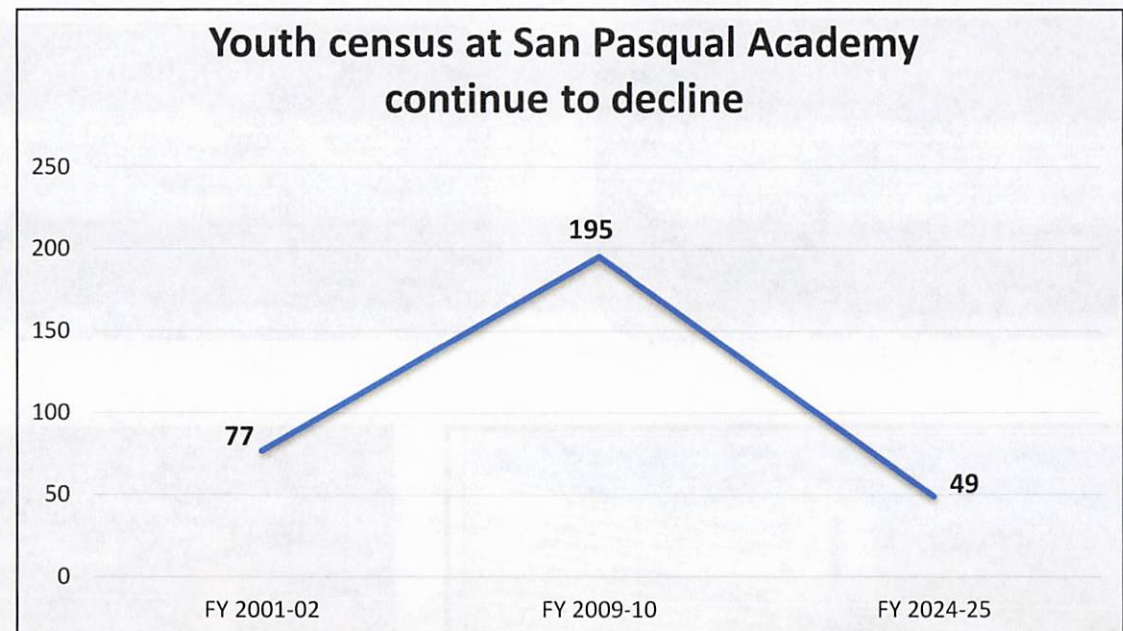
2025 – Number of youth placed at San Pasqual Academy continue to decline, along with number of eligible youth.



Current Status (Fiscal Year 2024-25)



- **555** eligible youth
- **379** youth placed with kin and foster families
- **95** youth with higher-level needs required placements other than San Pasqual Academy
- **49** youth placed at San Pasqual Academy

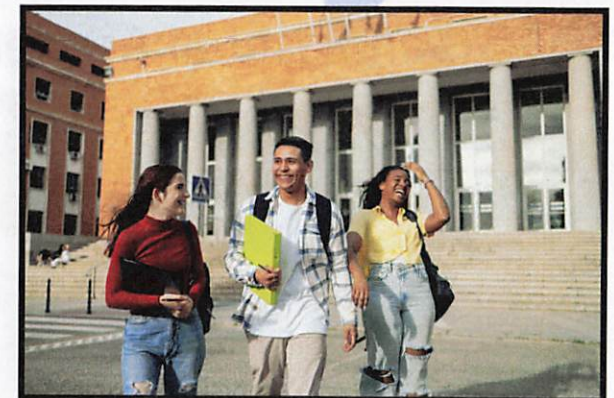
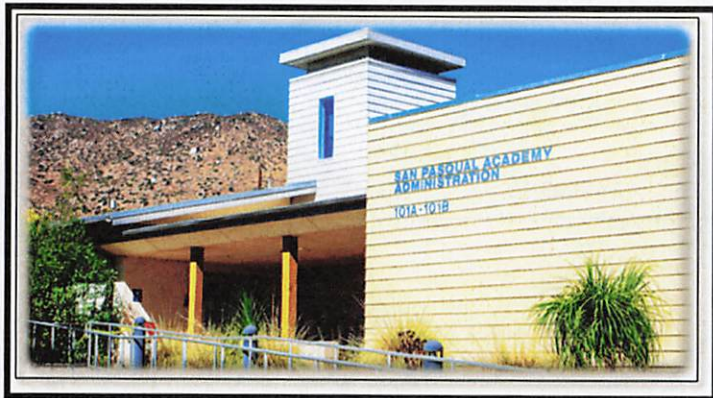

Recommendations



1. Direct the Chief Administrative Officer, or designee, to conduct stakeholder engagement including current and former foster youth, Child and Family Well-Being staff, Juvenile Court partners, education partners, Child and Family Strengthening Advisory Board, community organizations that support foster youth, and other key stakeholders that support foster youth and San Pasqual Academy (Academy), to develop recommendations for best serving foster youth, maximizing the use of the Academy campus, and ensuring fiscal sustainability of foster youth programming.
2. Direct the Chief Administrative Officer, or designee, to return to the Board of Supervisors (Board) in 180 days with recommendations for the Board's consideration to ensure the Academy campus can benefit individuals and families in the region to the greatest extent possible while also ensuring sustainable programs.
