Dear Chairwoman Vargas and Supervisors:

On behalf of the YIMBY Democrats of San Diego County, please accept this letter of support for the Midway Rising project and use of an EIFD located in the Midway community.

The YIMBY Democrats of San Diego County are dedicated to growing San Diego in the communities where we live. In addition to developing more affordable and market-rate housing to increase the supply of housing, we believe in prioritizing infill development near transit and employment centers with the goal of increasing our housing supply, leveraging our urban environments, protecting our natural resources and advancing economic inclusion and opportunity for all. Further, we believe that sound public policy, along with projects such as Midway Rising will result in a more equitable and housing rich City.

Midway Rising will deliver 4,250 housing units while updating a 16,000-seat arena and entertainment center within the Midway community. The project includes 2,000 affordable units at 30 to 80 percent AMI and 2,250 market rate units. The affordable units will be broken down by: family housing, seniors, veterans, and homeless. The project includes transit enhancements such as digital signage, an on-site mobility hub, secured bike parking, and wayfinding. Located in an urbanized and smart growth opportunity area, the project is also located near an existing transit facility. There is an inherent benefit of dense housing directly next to transit, as it provides transit options.

The EIFD mechanism is another key advantage. Capturing increased tax revenue from the development allows for targeted investments within the Midway district. This can directly fund the creation of additional affordable housing units, alongside vital infrastructure improvements like parks, roads, and public transportation – all crucial for enhancing the Midway community's overall well-being.



Given San Diego's housing affordability challenges, the YIMBY Democrats of San Diego County strongly support the Midway Rising project. It presents a well-rounded solution that increases housing stock, fosters inclusive growth, and strengthens the Midway community through responsible development practices.
