**Item or Service and Term Period**: Jail Reentry Case Management Application (CMA) through Request for Proposal (RFP) for up to one initial year and four one-year option periods and up to an additional six months if needed.

Benefit to the County of San Diego: A Jail Reentry Case Management Application to be deployed in the Government Cloud (GovCloud). This design will be more secure and agile for implementing technological advancements, providing exceptional system resilience, and meeting the region's public safety needs of today and in the future. Within a safe and expandable GovCloud infrastructure, the system will optimize case management procedures, enhance program tracking and guarantee adherence to legal and regulatory requirements. The new application will track information for programs and the individual staff member to include security clearances, dates, times, specific facility areas visited, and the evidence-based curriculum they are using. It will make following program services and outcomes efficient and accurate and allow for expanded analysis for individual program outcomes.
