

Overall Sentiment







Looks good at first glance. I appreciate the emphasis on budgeting for expenditure increases or revenue shortfalls and tightening up of language such as "implementation of the Strategic Plan" vice the vague "service objectives." I also like that the County Counsel will now review grant agreements to make sure that the County's interests are protected. Too many grants have unanticipated conditions hidden in them and sometime have bad results.

One thing that disturbs me is where the fees section of policy B29 says "2. Provide for fees to be deposited or paid in advance. Delivery or completion of service, if applicable, is not to be made unless full payment has been deposited. Penalty provisions are to be established for delinquent payments of regulatory type licenses or permits."

Exceptions should be made for emergency circumstances, like a major leak from a sewer connection where the responsible party is unable to come up with the money for the fee right away.
