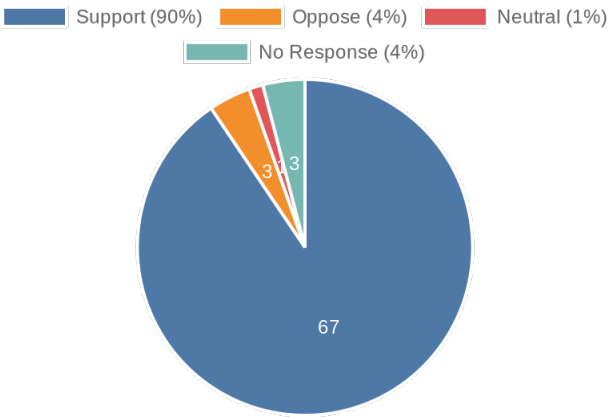

Overall Sentiment

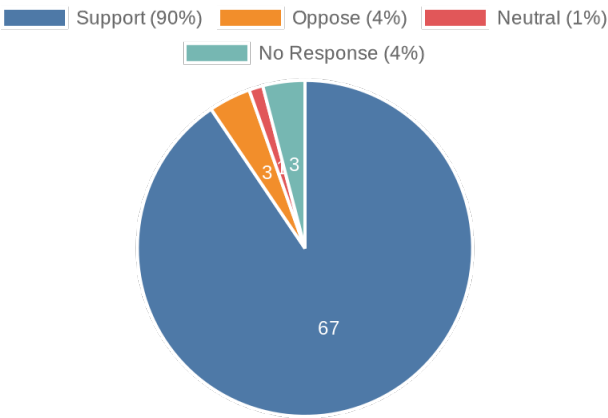

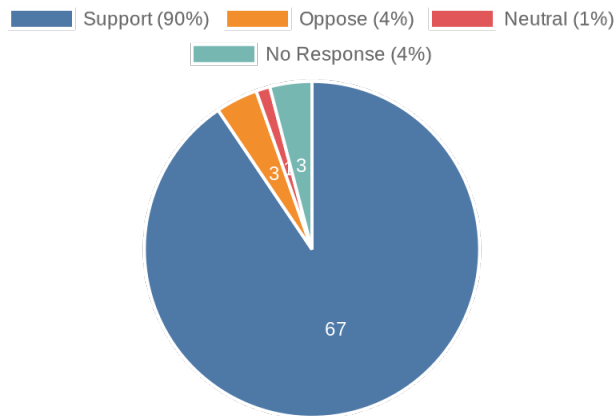

It's a good idea, but premature since Congress seems to be on the verge of restoring some or all of these cuts.

A 5% administrative fee out of \$18 mil is \$900,000. But it looks like we're just giving \$4 mil for a year and 5% would be only \$200 K. This would be matched 1 to 1 by the San Diego Foundation. I hope it is financially stable enough. So \$8 mil divided by an estimated 400 K SNAP recipients=\$20 per person. Minus 5%. Can't we do better? Think of something better? Large community gardens or farms?

It's nice to be prepared, but this might end up being a more-or-less permanent carveout for a lack of SNAP funding which may not be permanent.
