ORDINANCE NO. 10998 (NEW SERIES)

AN ORDINANCE AMENDING ARTICLE X-A OF THE SAN DIEGO COUNTY ADMINISTRATIVE CODE RELATING TO FEES CHARGED BY THE CLERK OF THE BOARD OF SUPERVISORS FOR COPIES OF AUDIO RECORDINGS, PASSPORT PHOTOS, MONEY ORDER TRANSACTIONS, AND WRITTEN ASSESSMENT APPEALS BOARD FINDINGS AND CONCLUSIONS

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. Article X-A, Section 160.2 of the San Diego County Administrative Code is hereby amended to read as follows:

SEC. 160.2. FEE FOR COPIES OF AUDIO RECORDINGS.

The fee for providing an audio recording on compact disk is \$11.20 per disk.

Section 2. Article X-A, Section 160.3 of the San Diego County Administrative Code is hereby amended to read as follows:

SEC. 160.3. FEE FOR PASSPORT PHOTOS.

The fee for providing passport photos is \$17.10 for two photos.

Section 3. Article X-A, Section 160.5 of the San Diego County Administrative Code is hereby added to read as follows:

SEC. 160.5. FEE FOR WRITTEN FOR WRITTEN ASSESSMENT APPEALS BOARD FINDINGS AND CONCLUSIONS.

The fee for written findings of fact for Property Tax Assessment Appeals Board Findings and Conclusions shall be \$413.00. The San Diego County Assessment Appeals Boards and Assessment Hearing Officers Rules of Procedure shall describe the process for payment.

Section 4. Article X-A, Section 160.7 of the San Diego County Administrative Code is hereby amended to read as follows:

SEC. 160.7. FEE FOR MONEY ORDER TRANSACTION.

The fee for a money order transaction is \$3.10.

Section 5. Effective Date. This ordinance shall take effect thirty (30) days after its adoption. Within fifteen days after the date of adoption of this ordinance, a summary shall be published once with the name of those members voting for and against the same in the newspaper of general circulation published in the County of San Diego.

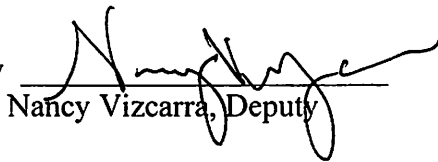
