





The claim of 99.9% peer-reviewed consensus on human-caused climate change is overstated; a 2021 Cornell study found 99% agreement, but critics note methodological biases, like excluding dissenting papers.

San Diego's environment is vital, but the Supe's claims of federal dismantling are exaggerated. NOAA's budget cuts are proposed, not enacted, and no evidence confirms 25% workforce losses or buoy shutdowns. EPA's budget faces a proposed 65% cut, but Superfund programs continue; Camp Pendleton's remediation is ongoing. Also, the \$1M San Diego grant revocation lacks verification. Health impact estimates (8,000 deaths, \$25B costs) are speculative, based on *worst-case models*, not current data. We have better things to spend our time and money on than this item.
