ORDINANCE AMENDING SECTIONS 72.161.91., 72.161.93., 72.169.32., AND 72.169.98. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.161.91. of the San Diego County Code is hereby amended:

SEC. 72.161.91. RANCHO SANTA FE. The prima facie speed limit on La Granada between Avenida de Acacias and Avenida Maravillas is hereby decreased to and established at 45 miles per hour.

Section 72.161.93. of the San Diego County Code is hereby amended:

SEC. 72.161.93. RANCHO SANTA FE. The prima facie speed limit on La Granada between Avenida Maravillas and Los Morros is hereby decreased to and established at 40 miles per hour.

Section 72.169.32. of the San Diego County Code is hereby amended:

SEC. 72.169.32. EL CAJON. The prima facie speed limit on Horizon Hills Drive and Rolling Hills Drive between the easterly limits of the City of El Cajon and the northerly line of Fuerte Drive is hereby decreased to and established at 35 miles per hour.


Section 72.169.98. of the San Diego County Code is hereby amended:
