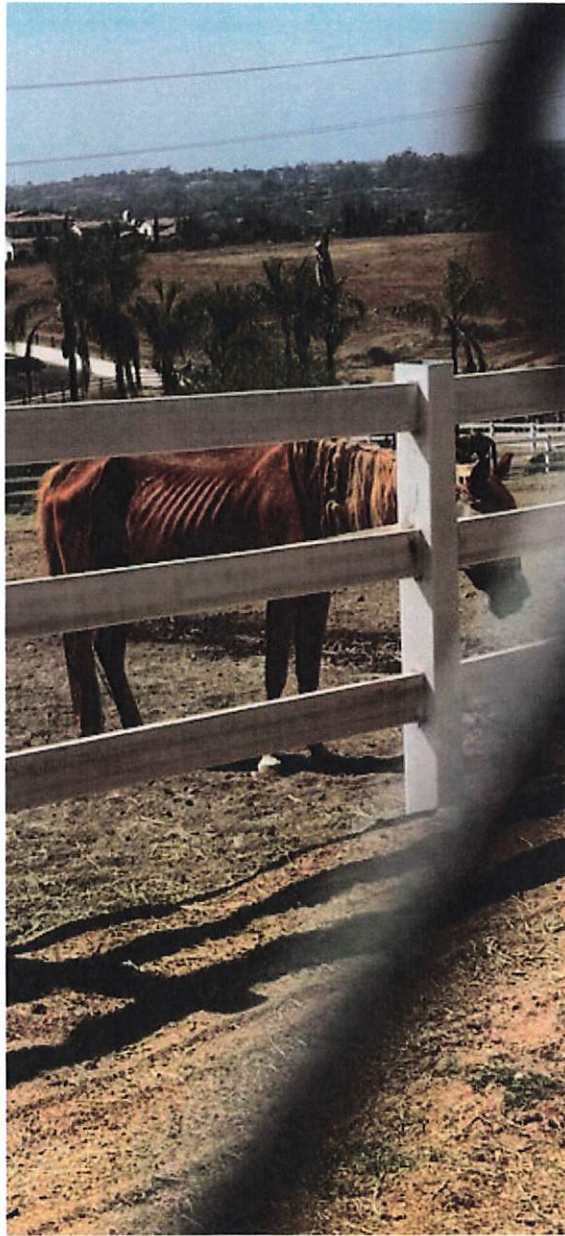

PUBLIC DEMAND FOR HELP TO DA SUMMER STEPHAN

DA Summer Stephan's own words: "Silence just allows the perpetrators to continue."



Malaika and Xayah's loving grandfather, Ricky Robinson, the Robinson-Lopez family, independent social workers, advocates, journalists, and a growing community are asking you to investigate what San Diego County has done to Malaika and Xayah — and to their entire family, including seniors and elderly dependents harmed by the County's retaliation for protected speech.

Malaika and Xayah are living in grave danger in the hands of San Diego County. They were wrongfully taken, catastrophically traumatized in County control, severed from family, and targeted for adoption despite a proven maternal bond and expert warnings of catastrophic psychological and emotional harm.

This case involves retaliation, bias, gross misconduct, abuse of power, criminal intent, malicious prosecution, reckless disregard for human life, retaliatory persecution, retaliatory restraining orders, false allegations placed into court records, Fourteenth Amendment violations, violation of human dignity, covered-up abuse and sexual-abuse concerns, elder harm, family destruction, and a gross miscarriage of justice.



Investigate San Diego County for state cruelty. Bring Malaika and Xayah home.
