Key Immigration-Related Laws

- The TRUST Act, Assembly Bill 4 (Chapter 570, Statutes of 2013), which limits the circumstances under which local law enforcement can detain individuals on behalf of federal immigration authorities.
- The TRUTH Act, Assembly Bill 2792 (Chapter 768, Statutes of 2016), which ensures transparency and oversight regarding local law enforcement's communication with federal immigration authorities.
- The VALUES Act, Senate Bill 54 (Chapter 495, Statutes of 2017), which limits the circumstances under which local law enforcement may use funds or personnel to support immigration enforcement and prevents police officers and sheriff's deputies from asking about an individual's immigration status, from sharing a person's personal information with immigration authorities, unless otherwise required or permitted by law, or from arresting anyone only for having a deportation removal order or for most other immigration violations.

San Diego Sheriff's Office Role with Immigration-related Enforcement

- **DO NOT** ask immigration status
- **DO NOT** investigate or enforce immigration law
- **DO NOT** detain an individual for an ICE hold request
- **DO NOT** participate in immigration raids, checkpoints, or mass deportations
- **DONOT** provide personal information, about an individual, including, but not limited to, the individual's home address or work address unless that information is available to the public
 - **DO** share release date information or transfer to ICE when an individual is convicted of a qualifying crime (individual is already in San Diego County Jail custody) or unless authorized by a judicial warrant
 - **DO** participate in regional task forces and enforce state and federal law related to narcotics, transnational criminal activity, human trafficking, weapons, terrorism and other violent criminal acts that do not focus on immigration enforcement

Release Authority per SB 54 (Gov Code 7282.5)

The incarcerated individual qualifies if they are:

- · Convicted of a serious or violent felony; or
- Convicted of a felony that is punishable by imprisonment in state prison; or
- Convicted within the past 5 years of a misdemeanor for a crime that is punishable as either a misdemeanor or felony; or
- Convicted of specific offenses within the last 15 years of a felony; or
- A current registrant on the California Sex and Arson Registry; or

- Convicted of a federal crime that meets the definition of an aggravated felony; or
- Currently facing a charge for a crime that is considered a serious or violent felony or is punishable by a term in state prison and where a judge has made a probable cause finding; or

Judicial Warrants override state law.

HOW THE JAIL PROCESS TAKES PLACE

ICE WANTS TO SPEAK WITH/INTERVIEW AN INDIVIDUAL IN SHERIFF'S CUSTODY

SDSO Action

SDSO screens the request to determine if the individual meets the qualifying charges.

- If they don't meet the qualification, the process ends, and the individual will receive a copy of the form for their records.
- If they meet the qualification, SDSO provides an ICE interview consent form to the individual (J-330 form).
 - If the individual meets the qualification, then:
 - The incarcerated individual receives the consent form (available in preferred language), and determines if they want to:
 - Deny interview request; or
 - Approve the interview request; or
 - Approve with their attorney present

HOW THE JAIL PROCESS TAKES PLACE

ICE WANTS TO RECEIVE A NOTIFICATION ON THE RELEASE DATE OF AN INDIVIDUAL IN SHERIFF'S CUSTODY

SDSO Action (*if release date is available*)

SDSO screens the request to determine if the individual meets the qualifying charges.

- > If they don't meet the qualification, the process ends.
- > If the individual meets the qualification, and their release date is available, then:
 - The incarcerated individual receives a J-335 form (available in preferred language), which notifies them that ICE will be contacted on the day of their release. *The call is for notification purposes only. We do not schedule or coordinate a person's release with ICE, nor is the release delayed as part of this process.*

HOW THE JAIL PROCESS TAKES PLACE


ICE WANTS TO RECEIVE A NOTIFICATION ON THE RELEASE DATE OF AN INDIVIDUAL IN SHERIFF'S CUSTODY

SDSO Action (*if release date is unknown/not available*)

SDSO screens the request to determine if the individual meets the qualifying charges.

- > If they don't meet the qualification, the process ends.
- > If the individual meets the qualification, and their release date is not available, then:
 - The incarcerated individual receives a J-340 form (available in preferred language), which notifies them that ICE is interested in their release date and will be notified once that date becomes available.

2024 ICE INTERVIEW REQUESTS







2025 TRUTH ACT COMMUNITY FORUM

San Diego Immigrant Rights Consortium

The current Trump Administration threatens due process, human rights, and our safety

SD Sheriff's continued collusion with DHS/ICE aids the current administration's inhumane immigration policies that deny people's human rights and due process.

- Immigrant communities are living in fear under the current administration's immigration policies.
 - They are afraid to go to work, go to school, go to church, seek medical help, seek government services, and call law enforcement.
- People are being disappeared off the streets, from their homes, and from work. DHS/ICE officials are accessing schools, churches, hospitals, and our data.
- Immigrants are being asked to sign voluntary departure forms under duress, with false representations, without due process, and without access to legal counsel.
 - Immigrants in ICE custody are being told they will go home, but instead are at risk of being sent to CECOT which is known for human rights violations.



SD Sheriff's Actions Puts Community at Risk and Fosters Distrust in Law Enforcement

SD Sheriff's continued collusion with DHS/ICE aids in the unjust detention, deportation and separation of families in our region.

- Transferring individuals to ICE and notifying ICE when individuals are being released from jail creates a dual criminal justice system & punishes immigrants twice for the same crime.
- Allowing DHS/ICE access to county property including jails and parking lots, creates distrust in County agencies, which prevents immigrants from accessing key services.
- Sharing data, information and resources with DHS/ICE poses a risk not only to immigrant's security but all of our data.

SDSD collusion with DHS/ICE creates fear and mistrust of local law enforcement AND local government. It undermines trust and confidence in law enforcement, making our communities and families in San Diego County feel less safe.



Compliance With San Diego County Board Policy L-2 Is Required To Follow State Law and Maintain Public Trust

SD Sheriff Kelly Martinez has been very public about her refusal to comply with county board policy L-2 and her resolve to continue conducting ICE notifications and transfers using county resources and funds.

- The California Values Act (SB 54) makes clear that local law enforcement agencies "shall not use agency or department moneys or personnel to investigate, interrogate, detain, detect, or arrest persons for immigration enforcement purposes.
 - It allows for limited exceptions so long as they do not violate any state or local law, or local policy.
- Now that the County Supervisors passed a local policy prohibiting the use of county resources and funding for immigration enforcement, it is clear that ICE notifications and transfers without judicial warrants violate local policy and state law.



SDSD Transfers & Notifications to ICE

2024 Data

- 218 immigrants were subject to ICE notifications and transfers for deportation.
- ICE transfer numbers have been increasing. In 2022, there were 18, in 2023 there were 25, and in 2024 the Sheriff transferred 30 individuals to ICE.
- SDSD is not being transparent in identifying whether transfers occurred as a result of a judicial warrant when they list "federal warrants" on transfer reports.

- CA State law allows the Sheriff to notify ICE and transfer certain individuals to ICE, but it DOES NOT require it.
- As of Dec 10, 2024, local policy prohibits the use of County resources and funding for immigration enforcement purposes unless there is a judicial warrant.
- The Sheriff refuses to comply with local policy and with state law SB 54.



SDSD Is Not Being Transparent

SD Sheriff transfer data indicates "federal warrant" but does not indicate a qualifying conviction, qualifying date or if there was a judicial warrant.
