Dear Chair Vargas:

Under your Agenda Item 29, if an illegal immigrant commits one of a number of heinous crimes, the County would be barred from informing ICE, effectively preventing their deportation and allowing them to remain in our communities. I don't have a single family member, friend or neighbor who wants our community to be less safe! We must work with all agencies to ensure that dangerous criminals here illegally are REMOVED in a expeditious manner in order to protect us all. Please withdraw this wrong-headed item from the agenda.

We entrust our county supervisors to do what is best for the safety and well-being of our County. So, why are we spending \$5 million annually to provide attorneys for illegal immigrants facing deportation? Just deport them. They are here illegally. Agenda Item 29 would then aim to prioritize the interests of illegal immigrants even further, doing so at the expense of the safety and well-being of U.S. citizens. No. This is wrong.

No Agenda Item 29 is wrong. We deserve to be safe and to have our agencies working together to keep us that way. Please withdraw this proposal.
