STATE OF PUBLIC HEALTH UPDATE (JANUARY 1, 2024, THROUGH DECEMBER 31, 2024)

On August 30, 2022 (4), the County of San Diego (County) Board of Supervisors (Board) authorized the acceptance of \$14,356,108 from the California Department of Public Health (CDPH) Future of Public Health (FoPH) funding, for the fiscal year period of July 1, 2022, through June 30, 2023. Subsequently, on August 29, 2023 (5), the Board authorized acceptance of \$43,068,324 from the CDPH FoPH funding allocation, for the period of July 1, 2023, through June 30, 2026.

The funding is intended for investment in local health departments, based on the Foundational Public Health Services Framework (framework). This framework outlines the unique responsibilities and explains the vital role of governmental public health in a thriving community; identifies capacity and resource gaps; determines the cost for assuring foundational activities; and justifies funding needs. As a requirement to accept CDPH FoPH grant funding, this memorandum serves as an update on the state of public health in San Diego County, including population health outcomes, strategic planning efforts, program outcomes, and policy recommendations for January 1, 2024, through December 31, 2024.

San Diego County at a Glance

With a population of nearly 3.3 million, San Diego County is the second most populous county in California and the fifth most populated in the United States (U.S.). San Diego County has a majority minority population comprising 58.1% of the total population, the remaining 41.9% are non-Hispanic (NH) White. The minority population consists primarily of Hispanic or Latino at 34.9% of the total population, followed by NH Asian/Native Hawaiian Pacific Islander (12.6%), NH multiracial (5.4%), NH Black (4.3%), and 1% were of another race (NH American Indian/Alaska Native or other). About one-fifth (20.6%) of residents were under the age of 18, 57.6% were between 18 and 59 years of age, and 21.8% were 60 years or older.

Notable social determinants in San Diego County include poverty, health insurance status, and educational attainment. In 2023, 10% of residents lived in poverty, nearly 6% of residents did not have health insurance coverage, and 11% of adults 25 years and older did not have a high school diploma.

In addition to leading causes of morbidity and mortality, public health issues that exemplify the current state of public health in San Diego County include (listed alphabetically): Human Immunodeficiency Virus (HIV) and other Sexually Transmitted Infections; Infant Mortality; and Tuberculosis (TB) (active disease and latent infection), amongst others. Health equity transcends each of these public health issues and Public Health Services (PHS) has been and continues to be committed to focusing on health inequities to protect residents most vulnerable to poor health outcomes. Equity is a key focus within the PHS strategic priorities, goals and objectives; data visualization efforts; and a centralized focus for the 10 Essential Public Health Services national framework. The framework incorporates current and future public health practices to protect and promote the health of people in all communities and is the foundation for national public health accreditation. These efforts align with the County focus on equity and racial justice.

Population Health Outcomes

1. Morbidity

In 2023, the leading cause of emergency department (ED) discharge in San Diego County was due to unintentional injuries (including transportation injuries, falls, accidental poisoning and exposure to noxious substances, accidental exposure to smoke, fire, or flames, etc.), with an age-adjusted rate of 5,129.9 per 100,000 residents. The next greatest cause of ED discharge in San Diego County was due to overall heart disease, for which there was an age-adjusted rate of 1,762.3 per 100,000 residents discharged in 2023. In San Diego County, from 2021 to 2023, the top three leading causes of ED discharge were unintentional injuries, overall heart disease, and urinary tract infection in each year.

The leading cause of hospitalizations in San Diego County, in 2023, was due to overall heart disease, with an age-adjusted rate of 848.2 per 100,000 residents. In 2023, the age-adjusted hospitalization rate due to unintentional injuries, the second most common cause of hospitalization among San Diego County residents, was 823.2 per 100,000. Among hospitalizations, overall heart disease and unintentional injuries have remained the top two concerns from 2021 to 2023. In 2021 and 2022, overall cancer was the third leading cause of hospitalization, while in 2023, non-Alzheimer's dementia (any mention of the disease) was the third leading cause of hospitalization.

2. Mortality

In 2023, the top five leading causes of death among San Diego County residents were cancer, diseases of the heart, unintentional injuries, stroke, and Alzheimer's disease. Of note, cancer and diseases of the heart caused 42.2% of deaths among San Diego County residents in 2023 and 40% on average every year between 2021 and 2023. While cerebrovascular diseases have consistently been one of the top five leading causes of death in San Diego County between 2021 and 2023, unintentional injuries surpassed cerebrovascular diseases and COVID-19 in 2022, becoming the third leading cause of death that year and remained in third for 2023. Moreover, Alzheimer's disease reentered the top five leading causes of death in 2023, climbing to the fifth position, reflecting its growing importance as a leading cause of death as the population ages and the impact of COVID-19 decreases.

Life expectancy is a widely used indicator for the capability to live a long and healthy life and reflects the overall mortality of a population. A baby born in San Diego County, in 2023, had a life expectancy of 81.0 years, but within San Diego County, there was an 8.5-year gap in life expectancy between some

communities. Within San Diego County, the Coastal and Southeastern San Diego subregional areas showed extremes, with life expectancies of 86.7 and 78.2, respectively.

3. Morbidity and Mortality 3-Year Growth

While the number of deaths is quite low, asthma had the most rapid three-year growth rate for mortality. Specifically, San Diego County experienced a 35% increase in the number of deaths due to asthma from 2021 to 2023 (17 and 23 deaths, respectively). However, it is important to note that from 2016-2023, in San Diego County, the number of deaths due to asthma have been relatively stable except from 2020-2022, during which time the COVID-19 pandemic affected the patterns of mortality. Likewise, COVID-19 affected the patterns of morbidity from 2021 to 2023. During the peak of the COVID-19 pandemic, influenza activity sharply decreased in San Diego County due to the implementation of public health measures like social distancing, mask-wearing, and travel restrictions aimed at controlling its transmission. Following the easing of COVID-19 restrictions, influenza activity rebounded, returning closer to pre-pandemic patterns.

Policies to Address Morbidity and Mortality

Health in all Policies (HiAP) is a proven approach to mitigate chronic disease, which addresses the causes and concerns of morbidity/mortality mentioned in this memorandum. HiAP recognizes that health is created by a multitude of factors beyond healthcare and public health, also known as the social determinants of public health (e.g., education, income, and the conditions in which people live, work, and play).

One example using the HiAP approach is the San Diego Racial and Ethnic Approaches to Community Health (REACH) program that focuses on communities where there are disparities and high numbers of residents with uncontrolled high blood pressure or who are at risk for type II diabetes. Another example is the CalFresh Healthy Living Program (SNAP-Ed), which includes interventions that improve access to healthy food and active living opportunities where SNAP-Ed eligible people live, play, shop, eat, worship, and work. Even though SNAP-Ed is a great example for last calendar year, 2024, it is important to note that as of September 30, 2025, funding for this program is ending. Other programs include the Lactation Supportive Environments, Sodium Reduction Initiative, Childhood Obesity Initiative, and Tobacco Control Resource Program; all of which incorporate policy approaches affecting the conditions or environment in which people live. Additionally, HiAP aligns with the County use of targeted universalism by ensuring that while overall health goals are set for everyone, strategies are adapted to meet the specific needs of different communities to achieve equitable outcomes.

Health Disparities, Strategies, Outcomes, and Policy Recommendations


PHS is committed to excellence across all programs and services, including infectious disease control, prevention services, surveillance, California Children's Services, health promotion, maternal and child health, and Public Health Preparedness and Response. These programs are specified in the annual County Operational Plan for PHS for fiscal years 2022-23 & 2023-24. These programs and services have strategies in the PHS Strategic Plan with a Strategic Framework aligning with several Board, County, HHS, and department initiatives addressing health disparities and ensuring equity for all.

Highlights telling the story of data leading to impact with community partners through a collective impact approach are shared in the PHS Strategic Plan Health Equity and Population Health Goals showing how the department is addressing the health disparities mentioned in this memo. Attachment A outlines the four public health issues (infant mortality, syphilis, HIV, and tuberculosis) including key health disparities, strategies, outcomes, and policy recommendations as PHS created elimination initiatives to mitigate the four public health issues.

PHS is committed to delivering exceptional and quality public health services by aligning with national, State, and local standards. The endeavors listed above and in Attachment A align with national public health practices and concepts, as identified in the Foundational Public Health Services Framework. In addition, these efforts align with the County vision of a just, sustainable, and resilient future for all, specifically those communities and populations in San Diego County that have been historically left behind. Lastly, these efforts have ongoing commitment to the regional *Live Well San Diego* vision of healthy, safe, and thriving communities. The success of PHS is accomplished by ensuring goals, strategies, objectives, activities, and expected results of the PHS Strategic Plan are achieved and aligned with County and HHSA priorities.

SAN DIEGO PUBLIC HEALTH ISSUES

Infant Mortality (Pages 88-90 of PHS Strategic Plan)	
Disparity	San Diego County's NH Black infants are about six times more likely to die before reaching their first birthday, compared to White infants (9.6 vs. 1.5 deaths per 1,000 live births, averaging 2020 to 2022).
Strategy	PHS has three programs offering services and resources addressing infant mortality: 1) Black Infant Health (BIH) Program; 2) Perinatal Equity Initiative (PEI) ; and 3) Birth Equity Program. In 2024, PEI creatives (brochures, door hangers, and postcards) were distributed in the community to promote educating NH Black mothers on the importance of advocating for equitable and dignified maternity health treatment for themselves and their babies.
Measure	Reduce the three-year average infant mortality rate per 1,000 live births to no more than 5.0 deaths by 2030 with a focus on reducing the infant mortality rate for NH Black infants, which currently in San Diego County is 9.6 deaths.
Outcome	Ensured 92% (47 of 51) of infants served by the BIH Program had a normal birth weight (2,500 grams or more).
Policy	See recommendations in Call to Action section of White Paper .
Syphilis (Pages 68-71 of PHS Strategic Plan)	
Disparity	The rate of early syphilis in NH Black females is 3.2 times that of White females. In 2023, congenital syphilis rate increased by 1,276.8% since 2013 and by 8.2% since 2022.
Strategy	PHS leads a monthly Congenital Syphilis Working Group with over 20 County staff from PHS (e.g., HSHB, Maternal Child and Family Health Services), Office of Homeless Solution and Equitable Communities, Nursing, and Behavioral Health Services to decrease the rate of congenital syphilis. There are three sub-committees focused on awareness and prevention, surveillance, and testing and linkage to care.
Measure	Appropriate diagnostic evaluation and/or treatment is confirmed for 100% of infants born to individuals with untreated or inadequately treated syphilis at the time of delivery.
Outcome	Confirmed 93% (348 of 373) of individuals of childbearing potential who were diagnosed with any stage of syphilis were screened for pregnancy status.
Policy	See recommendations in Call to Action section of White Paper .

SAN DIEGO PUBLIC HEALTH ISSUES

HIV (Pages 68-71 of PHS Strategic Plan)	
Disparity	In 2023, 49% of new HIV diagnoses were among Hispanic/Latinos.
Strategy	The Getting to Zero Initiative reflects a community-wide strategy and commitment to preventing HIV infection and addressing rising sexually transmitted disease rates., with PHS serving as the backbone. The County continues to deploy funding for community engagement. During the past five years, the County has funded community engagement efforts focused on Black, Hispanic, and transgender residents. In April 2024, PHS launched the Harm Reduction Services Program, providing integrated disease screening activities including HIV and hepatitis C testing, wound care, provision of harm reduction supplies (naloxone, fentanyl test strips, and syringe services), referrals to wrap around services (substance use treatment, mental health, housing, food, etc.), and health education.
Measure	Reduce the HIV disease diagnosis case counts in San Diego County by 90% (from 2017 baseline of 422 to 42 by 2030), aligning with the Getting to Zero Initiative .
Outcome	Connected 94% (33 of 35) of clients with newly confirmed HIV diagnoses to primary care within 30 days to improve health outcomes and reduce transmission of HIV.
Policy	See recommendations in Call to Action section of White Paper .
TB (Pages 112-115 of PHS Strategic Plan)	
Disparity	The highest numbers of TB diagnoses and incident rates occur in the South and Central Regions of the San Diego County from 2019-2023.
Strategy	The San Diego County TB Elimination Initiative (TBEI) is a public-private partnership focused on effective TB prevention, including risk assessment, testing, and treatment of latent TB infection (LTBI) cases to prevent progression to active TB disease. The TBEI Community of Practice (CoP) convenes provider organizations throughout San Diego County that serve populations at risk for TB (e.g., South and Central Regions). The CoP has been a successful forum to advance TB elimination partnership and infrastructure in San Diego County through sharing of practices for provider and patient education and electronic medical record enhancements that have improved access to and acceptance of LTBI care in San Diego. In 2024, the TBEI CoP was recognized with a CDC U.S. TB Elimination Champion award.
Measure	Reduce the annual TB incidence rate to 5 cases per 100,000 by 2030, compared to the 2015-2019 baseline of 7.4. This is a 30% reduction in cases (244 to 170); conduct outreach and education to medical providers in high TB incidence communities.
Outcome	Ensured 98% (207 of 212) of active TB cases were reported by the community to PHS within one business day from the start of treatment to prevent further transmission.
Policy	See recommendations on TBEI website .







HIV

In 2023, 49% of new HIV diagnoses were among Hispanic/Latinos.¹³

The Getting to Zero initiative reflects a community-wide strategy and commitment to preventing HIV infection and addressing rising STD rates, with the HIV, STD and Hepatitis Branch of PHS serving as the backbone. The County continues to deploy funding for community engagement. During the past five years, the County has funded community engagement efforts focused on Black, Hispanic, and transgender residents.

In April 2024, PHS launched the Harm Reduction Services Program, which provides integrated disease screening activities including HIV and hepatitis C testing, wound care, provision of harm reduction supplies (naloxone, fentanyl test strips, and syringe services), referrals to wrap around services (substance use treatment, mental health, housing, food, etc.), and health education.

Reduce by 90% the HIV disease diagnosis case counts in San Diego County (from 2017 baseline of 422 to 42 by 2030), aligning with the Getting to Zero Initiative.¹⁴

Connected 94% (33 of 35) of clients with newly confirmed HIV diagnoses to primary care within 30 days to improve health outcomes and reduce transmission of HIV.

NORTH COUNTY MULTIPLE SPECIES CONSERVATION PLAN (NORTH COUNTY PLAN): FALL 2025 PROGRESS & OUTREACH UPDATE

On October 28, 2020 (6), the Board of Supervisors (Board) directed Planning & Development (PDS) and Department of Parks and Recreation (DPR) staff to continue the development of the draft North County Multiple Species Conservation Program (MSCP) Plan (North County Plan) as a joint Habitat Conservation Plan/Natural Community Conservation Plan (HCP/NCCP) based on feedback provided by County staff and an assessment completed by a consultant in regional conservation planning. The goal is to achieve similar environmental, economic, and community benefits realized through the South County Subarea Plan, adopted on October 22, 1997 (1), such as streamlined housing permits and the conservation of wildlife habitat. Staff were also directed to continue working with all stakeholders, especially the Farm Bureau, and analyze development opportunities along the Interstate 15 (I-15) corridor that allow for development and encourage conservation away from the corridor. This memorandum provides an update on the County's development of the North County Plan as of Fall 2025 since providing the Summer 2023 update (Attachment A) through collaboration with the United States Fish and Wildlife Service (USFWS) and the California Department of Fish and Wildlife (CDFW) – collectively referred to as the Wildlife Agencies.

UPDATE ON NORTH COUNTY PLAN COMPONENTS

Since the last update in Summer 2023, staff have made substantial progress on developing several key components of the North County Plan. Staff from PDS, DPR, General Services, Agriculture, Weights and Measures, Environmental Health and Quality, and Public Works, in coordination with the consultant team, have completed the Draft North County Plan and have been working closely with the Wildlife Agencies to discuss their feedback. Staff anticipate this process to be completed winter 2025, with a Public Draft made available in mid-2026 following final review by the Wildlife Agencies. Following public review, necessary revisions will be made before bringing the Final Plan to the Board, which is anticipated for late-2026 or early-2027.

Two major components were developed since our last update, including the North County Plan's Effects Analysis and Conservation Strategy. The Effects Analysis outlines the anticipated impacts to habitat of the 40 species covered under the North County Plan (Covered Species) in alignment with the General Plan and the mitigation (amount of future conservation) that is expected to result from those anticipated impacts. The Conservation Strategy outlines how the County intends to conserve, manage, and monitor natural resources that contribute to the long-term protection of the Covered Species and the habitat they rely upon, focused within the Existing Preserves and Priority Conservation Area (PCA), wherein the future preserve system will be established. Development of the Conservation Strategy included various meetings with species experts from the San Diego Management and Monitoring Program, United States Geological Survey, The Nature Conservancy, San Diego Natural History Museum, Conservation Biology Institute, San Diego State University, University of California, Davis, and Riverside County Habitat Conservation Agency to collect best-available information on species suitable habitat, threats and stressors, and management methods.

In accordance with the Board's direction in 2020, the Conservation Strategy also looks to balance conservation and development along the I-15 Corridor. For the purposes of the North County Plan, the I-15 Corridor is defined as a 2-mile buffer on each side of the I-15 within the North County Plan Area. Mitigation policies and project design considerations have been proposed to maintain critical habitat for the federally threatened coastal California gnatcatcher and the north-south connectivity function from the Otay/Mexico Border to Riverside County along the I-15 Corridor they rely upon. These proposed policies are consistent with the County's existing Community Design Review Special Area Regulation in the Zoning Ordinance and steep slopes policy in the Resource Protection Ordinance. Additionally, the North County Plan also includes biological mitigation exemptions for single-family residential development and agricultural operations to further streamline development projects both inside and outside the PCA. In general, these policies will facilitate conservation along the I-15 Corridor inside the PCA while still allowing development to occur.

STAKEHOLDER OUTREACH & ENGAGEMENT

Staff have adopted a proactive stakeholder engagement approach for the development of the North County Plan, which includes regular updates during standing industry group meetings with the North County Plan Stakeholder Working Group, which includes a diverse group of stakeholders that represent the environmental, agricultural, recreational, and development communities. These meetings are open to the public and provide communities with the opportunity to submit written and verbal comments.

Since 2021, staff have attended more than 200 standing industry group meetings as well as presented to the SANDAG Regional Habitat Conservation Taskforce and Fallbrook Climate Action Team, hosted seven public workshops, and convened the Stakeholder Working Group five times. Additionally, staff continue to attend quarterly Community Planning and Sponsor Group (CPSG) Chairs' meetings to provide progress updates and meet with Tribal Nations consistent with AB52 requirements in coordination with the County Tribal Liaison. As requested by Tribal members, County and USFWS staff also held a Tribal Coordination Meeting to receive feedback

on the Draft North County Plan and Working Draft Conservation Strategy on April 29, 2024. All Tribes within San Diego County were invited to participate. Feedback received focused on opportunities to collaborate with the County on land stewardship to incorporate traditional ecological knowledge, facilitate wildlife corridors, and allow Tribes to provide educational and cultural opportunities. A subsequent Tribal coordination meeting to discuss opportunities for preserve stewardship collaboration is anticipated for fall 2025.

To increase awareness of the project with the general public, staff attended Hawktober events hosted by DPR at Live Oak County Park in Fallbrook and Ramona Grasslands County Preserve in October 2024. Staff also participated in the MSCP Annual Workshop at the Mission Trails Regional Park Visitor Center on November 3, 2023, and Lakeside Community Center on November 22, 2024, the State of Biodiversity Symposium at the San Diego Natural History Museum on April 18, 2024, and April 8, 2025, and the County’s Earth Day Fair on April 22, 2024, and April 18, 2025, as well as other community events. Staff also attended a series of community and industry group meetings in Winter 2023-24 and Winter 2024-25 to provide an update on the progress of the North County Plan and the engagement forecasted for the upcoming year. Staff also provided progress updates at the quarterly Community Planning and Sponsor Group Chairs meetings on December 9, 2023, December 14, 2024, and June 14, 2025.

Public Workshops & Stakeholder Working Group

Public workshops and Stakeholder Working Group meetings are promoted through emails to interested subscribers, social media posts, industry group meeting presentations, and direct emails to relevant and interested stakeholders. Simultaneous interpretation is made available for attendees whose primary language is Spanish, with additional threshold languages offered by request. Workshop materials are offered in both English and Spanish on the project website and made available to attendees. Feedback is collected through interactive questions throughout the staff presentation, using the Q&A feature, and verbal discussions. Table 1 outlines the workshops and meetings hosted by the County since Summer 2023, the total number of participating attendees, and the number of comments received.

Following Stakeholder Working Group meetings and public workshops, meeting recordings in both English and Spanish and a summary of the input received are available on the project website. A summary of the input received at each outreach event is summarized below, and the input has been incorporated into the Draft North County Plan for additional review by County staff.

Effects Analysis & Conservation Strategy Approach

Key requests that arose from the input received include:

- Ensure that the public has reasonable and well-managed access to open spaces and educational activities
- Consider wildlife corridors, recreation areas, wildfire risks, and existing infrastructure when analyzing where future development is likely to occur
- Describe the NCCP Act required science advisor process, indicator species selection, and monitoring requirements for indicator species

Working Draft Conservation Strategy

Regarding the Conservation Strategy, comment letters were received from the San Diego Farm Bureau, Endangered Habitats League, Sierra Club, Wildlife and Habitat Conservation Coalition, San Diego Regional Water Quality Control Board, Southwest Wetlands Interpretive Association, and the Rancho Guejito Corporation. Key requests that emerged include:

- Ensure protection for currently listed and future listed species
- Conservation goals should be informed by science advisors' input and regional efforts, result in an interconnected preserve system of conserved lands, and allow for adaptive management
- Avoidance of impacts is the preferred approach before mitigation is necessary
- Policies and education related to recreation, invasive species, and pesticide use should be incorporated

Environmental Documents

The feedback during public review of the Environmental Documents include:

- Clarification on the planning process as it relates to timing of CEQA document preparation
- Confirm accuracy of agricultural land mapping
- Policies related to agricultural expansion exemptions and public access within the North County Plan Preserve System, as well as various other topics, should be addressed

NEXT STEPS

Since the spring 2025 workshops, County staff, consultants, and Wildlife Agencies have been developing and reviewing the Draft North County Plan and environmental documents. The collective team, including staff from the various County departments referenced previously, is developing the implementing documents, which will detail the requirements needed to bring forward the North County Plan. A Cost Analysis and Fee Nexus Study is being undertaken to estimate the overall County costs to implement the North County Plan and to evaluate in-lieu fee options for private development projects.

The implementing documents, and Cost Analysis and Fee Nexus Study, will be included with the Public Draft North County Plan and EIR during the public review period next year. Staff are developing a robust outreach strategy for the public review process, which will include the following key messages:

- Streamline development and other Covered Activities, including expansion of agriculture and preserve stewardship
- Establish an interconnected preserve system and a comprehensive monitoring and management plan for the long-term protection of the 40 Covered Species
- Facilitate fire suppression activities without additional requirements
- Provide accessible recreational and educational experiences for residents and visitors related to the natural and cultural resources of the region

As part of this public review process, staff will host a virtual public workshop and a Stakeholder Working Group meeting to provide an overview of the Public Draft North County Plan and how to submit comments. Staff will also coordinate with individual commenters to respond to their concerns and discuss how best to incorporate their feedback into the Final Draft North County Plan anticipated for Board consideration and adoption in 2026.

NORTH COUNTY MULTIPLE SPECIES CONSERVATION PLAN (NORTH COUNTY PLAN): SUMMER 2023 PROGRESS & OUTREACH UPDATE

Overview

On October 28, 2020 (6), the Board of Supervisors (Board) directed Planning & Development (PDS) staff to continue the development of the draft North County Multiple Species Conservation Plan (North County Plan) as a joint Habitat Conservation Plan/Natural Community Conservation Plan (HCP/NCCP) based on feedback provided by PDS staff and assessment completed by a consultant in regional conservation planning. The goal is to achieve similar environmental, economic, and community benefits realized through the adopted South County Subarea Plan, October 22, 1997 (1), such as streamlined housing permits and conserved habitat for wildlife. Staff was also directed to "continue working with all the stakeholders, especially the Farm Bureau, and helping to preserve and expand agricultural operations, consistent with the agricultural promotion program, [and] work with property owners".

This memorandum includes details on how PDS staff has proceeded with this direction through the development of the North County Plan in collaboration with the United States Fish and Wildlife Service (USFWS) and the California Department of Fish and Wildlife (CDFW), collectively referred to as the Wildlife Agencies, general public outreach, and focused stakeholder outreach. Staff meets monthly with the North County Plan Stakeholder Working Group, formed in 2017 which includes a diverse group of stakeholders that represent the environmental, agricultural, recreational, and development communities. These meetings are open to the public and provide communities the opportunity to directly submit verbal comments.

In addition to the stakeholder working group, Staff had focused meetings on the North County Plan with several groups such as the San Diego County Farm Bureau's Land Use Committee, San Diego Audubon Conservation Committee, Building Industry Association's North County Legislative Committee, and Parks Advisory Committee.

Additionally, staff attended quarterly Community Planning and Sponsor Group (CPSG) Chairs' meetings to provide progress updates and concurrently met with Tribal Nations in coordination with our County Tribal Liaison.

This update includes a summary of the components that have been developed since receiving Board direction in 2020, as well as an overview of the public workshops that were held in Fall 2021 and Spring 2023 to receive feedback on individual components from stakeholder groups and the public. Feedback is considered and integrated into individual components as the North County Plan is developed.

Update on North County Plan Components and Focused Engagement

Since receiving Board direction in 2020, technical modifications to the Plan Area (i.e., the geographic boundary that defines the extent of the analysis for the development of the North County Plan), Preserve Design (i.e., the area in which mitigation and conservation are anticipated to occur), and Covered Species list (i.e., those species within the Plan Area that will be conserved through the implementation of the North County Plan) were established as outlined in the North County Multiple Species Conservation Plan Status Review and Options Assessment (ICF, December 2019).

Modifications to refine policies and requirements that were part of the options selected by the Board, were also developed through monthly meetings with the Wildlife Agencies and stakeholders. This includes the impact and conservation analysis, which modified the development forecast to account for the revisions to the draft Plan Area and legislation affecting housing forecasts. Tools for assembling the preserve system were researched and presented to the Wildlife Agencies, including a potential in-lieu fee option for private development projects. Sixteen meetings were held with species experts to collect best-available information on species suitable habitat, threats and stressors, and management methods. Drafts of several North County Plan chapters and appendices have also been prepared, such as the Covered Activities (i.e., the private and public land uses, land and public infrastructure development, and conservation activities subject to the County of San Diego's jurisdiction and control that may impact the Covered Species), with subsequent review by the County and Wildlife Agencies.

In advance of public workshops, staff promotes the events through emails to interested subscribers, social media posts, stakeholder meeting presentations, and direct emails to relevant and interested stakeholders. Simultaneous interpretation was made available for attendees whose primary language is Spanish. Registrants could also request the presentation be interpreted in the other threshold languages prior to the workshops. The workshop materials were offered in both English and Spanish on the project website and made available to attendees by providing a link in the chat. Following the workshops, meeting recordings are available on the project website in both English and Spanish. At the virtual public workshops, community members participated in a staff and consultant-led presentation with interactive questions, along with a question and answer (Q&A) session at the end of the workshop. Throughout the workshops, participants are invited to share their perspectives through the interactive questions and Q&A feature. At the end

of the workshops, any remaining questions in the Q&A are answered live and members of the public are provided an opportunity to engage in an open discussion with staff.

Fall 2021

Staff and the consultant team hosted a North County Plan Stakeholder Working Group meeting on October 25, 2021 and two public workshops on November 30 and December 6, 2021 to receive feedback on those technical modifications to the revised Plan Area, Preserve Design, and Covered Species list. Staff met regularly with the San Diego County Farm Bureau, Building Industry Association, recreational and environmental stakeholders during standing stakeholder meetings. Staff attended the quarterly CPSG Chairs meeting on December 4, 2021 to notify all groups of outreach efforts, including the second virtual public workshop.

Considerable feedback was received in Fall 2021 on the Covered Species list, specifically to include additional species called “indicator species” that are not listed or likely to be listed but could serve as an indicator to monitor how well the preserve system is functioning. For the North County Plan, “indicator species” is defined as a species whose presence indicates elements of habitat structure and ecological function. Staff spent much of 2022 working with the Wildlife Agencies and stakeholder groups to develop a scientific methodology to include indicator species, in addition to progressing other key North County Plan components. The revised Covered Species list is included in Appendix A.

Winter 2022/2023

Staff attended a series of community and stakeholder meetings in late 2022 and early 2023 to provide an update on the progress of the North County Plan and the engagement forecasted for 2023. Staff also attended the quarterly CPSG Chairs meeting on December 3, 2022 to provide the progress update. A summary of the work accomplished to date, milestone schedule, and outreach materials are available on the [project website](#).

Spring 2023

Staff and the consultant team hosted a North County Plan Stakeholder Working Group meeting on April 14, 2023 and two public workshops on April 18 and 26, 2023, to receive feedback on the revisions to the Covered Species list to include indicator species based on previous input and the Covered Activities. Covered Activities are those private and public land uses, such as land and public infrastructure development, and conservation activities subject to the County of San Diego’s jurisdiction and control that may result in direct or indirect impacts to Covered Species that may require an Incidental Take Permit from the Wildlife Agencies during the term of the North County Plan. Staff continued to meet regularly with the San Diego County Farm Bureau, Building Industry Association, recreational and environmental stakeholders during standing stakeholder meetings. Staff attended the quarterly CPSG Chairs meeting on March 11, 2023 to notify all groups of outreach efforts, including the second virtual public workshop.

Overall, the information was well received by the Stakeholder Working Group with minor suggestions to ensure all activities that should be covered under the North County Plan are captured. At the virtual public workshops, 21 participants attended representing

environmental, economic, recreation, equity, and community organizations, as well as individual property owners with no declared affiliation.

Major themes that arose from the input received from participants are listed below. Theme order does not reflect importance or frequency.

- Preservation of the natural environment
- Ensuring that the public has reasonable and well-managed access to open spaces and educational activities
- Agriculture and land management practices
- Impacts of wildfire preparedness and mitigation activities

A summary document of the meeting objectives and format, how input was solicited, and what was learned from the participants is posted on the project website.

Next Steps

Since the Spring 2023 workshops, County staff, consultants, and Wildlife Agencies have been developing the Effects Analysis and Conservation Strategy and have reviewed these preliminary draft chapters. The Effects Analysis outlines the anticipated amount of impact to occur from the Covered Activities, including the modified development forecast. The Conservation Strategy outlines the preserve assembly tools and methods, including landscape-level, natural community, and species-specific conservation actions. The collective team, including staff from PDS, Parks & Recreation, and Public Works, is currently outlining the implementation strategy, which includes a criteria-based mitigation approach and in-lieu fee option for private development projects.

Staff continues to engage with the community and stakeholder groups and is identifying options for increasing outreach efforts to individual property owners. The next series of public workshops are anticipated for Fall 2023 to discuss the Effects Analysis and Conservation Strategy. Shortly thereafter, staff and the consultant team will publish the Notice of Preparation for the Environmental Impact Report/Environmental Impact Statement (EIR/EIS) and hold public scoping meetings to begin developing the environmental documents. Staff anticipates releasing the Public Draft North County Plan and EIR/EIS in late 2024, with the Final Draft North County Plan going to the Board for consideration in Fiscal Year 2025-26.

UPDATE ON IMPROVING YOUTH SAFETY IN JUVENILE DETENTION FACILITIES

On August 26, 2025 (26) the Board of Supervisors (Board) directed the Chief Probation Officer in collaboration with the Council of Juvenile Justice Administrators (CJJA) to report back within 60 days on plans for: 1) the phased elimination of chemical agents such as OC Spray in all youth detention facilities within two years, including the implementation of pilot programs at all youth facilities currently using chemical agents such as OC Spray, and 2) best practices both short and long-term to reduce and deemphasize the use of force and room confinement, which includes mandatory Mandt training for all Probation officers working in youth detention facilities, a timeline for the implementation of alternate forms of supervision and behavior management, and subsequent amendments to the Probation Department’s policies and procedures that will be needed.

These plans require close collaboration with internal and external partners, including County departments, justice-system stakeholders, the San Diego County Office of Education, employee associations, and community organizations. Given the shared timelines, goals, and interconnected strategies, the Probation Department (Probation) has developed an integrated implementation plan that unifies efforts to eliminate OC spray, reduce use of force, and limit room confinement into a single, phased roadmap.

This memo provides the Board with a 60-day update, outlining current efforts, early implementation activities, and next steps in the development of this integrated plan. Probation will continue to report back to the Board quarterly on progress. These are the latest efforts to create safer, more therapeutic environments for youth in custody. To address the Board’s directives regarding use of OC spray, use of force, and room confinement, it is important to provide context on the Department’s recent history of juvenile justice transformation. The following section highlights key milestones in that journey.

TRANSFORMING JUVENILE JUSTICE THROUGH STRATEGIC REFORM

Probation’s youth-focused reform efforts began with the Board’s action on February 2, 2016 (06), which authorized Probation to apply for an 18-month training and technical assistance opportunity through the

Youth in Custody Practice Model (YICPM). Developed by the Council of Juvenile Correctional Administrators (CJCA, now CJJA) in partnership with Georgetown University's Center for Juvenile Justice Reform (CJJR). The YICPM initiative selected San Diego County as one of only three national implementation sites.

The YICPM laid the foundation for Probation's approach to juvenile justice reform. Its core goals of promoting safe, fair, and healthy environments; equipping and empowering staff; increasing positive youth and family outcomes; and enhancing community safety remain central to current initiatives. These goals are guided by key principles shaping the Department's culture and decision-making. The model emphasizes developmentally appropriate, trauma-informed, and culturally responsive practices; individualized services based on validated assessments; strong family engagement; coordination across systems; and the use of data to inform outcomes. It also reflects a strength-based, research-informed approach anchoring Probation's strategy and expectations across all juvenile programs and facilities.

Over the past nine years, Probation has embedded these principles across its juvenile justice programs. With strong support from the Board, this work has unfolded through a series of strategic initiatives focused on staff training, facility redesign, community partnerships, and youth-centered programming. The following timeline highlights Board approved and supported milestones in this transformation, with each phase building toward safer, more therapeutic environments for youth in custody.

2016–2017 - Foundational Commitments to Reform: The Board approved participation in the YICPM initiative in 2016, positioning San Diego as one of only three national demonstration sites. This enabled trauma-informed staff training (T4), expanded Alternatives to Detention (ATD) programming, and planning for the Youth Transition Campus (YTC), a rehabilitative facility grounded in YICPM principles.

2018–2019 - Operational Shifts and Infrastructure Investments: The Board authorized development of community-based Achievement Centers and investments in facility life, including a shift to fresh, onsite meals and direct youth feedback on services. Probation implemented procedure changes in alignment with Senate Bill (SB) 1143 which limited the amount of time youths could be placed on room confinement. In 2019, the CJA Conditions of Confinement Study prompted a shift from law enforcement-style tactics to restorative approaches.

2020–2021 - Embedding Best Practices in Policy and Practice: During this period, Probation prioritized implementation of the Mandt System, a relationship-based crisis intervention model that emphasizes de-escalation and dignity in staff-youth interactions. The Department also expanded training on adolescent development, trauma-informed care, implicit bias, and restorative practices. Probation also strengthened individualized services through youth councils, internships, reentry planning, and implementation of a de-escalation team. The Board formally named the new facility the Youth Transition Campus in 2021 to reflect its reintegration-focused vision. During this period, Probation also collaborated with a subcommittee of the Juvenile Justice Coordinating Council to develop the local plan to receive approximately 70 youths and young adults realigned from state custody by SB 823.

2022–2023 - Enhancing Whole-Person Care: The Board approved enhancing the juvenile justice system through the continuation of Achievement Centers 6/13/2023 (2). Probation partnered with Health Management Associates to begin the planning and implementation of Transforming Medi-Cal, formerly known as CalAIM, to support 90-day pre-release services that went live October 1, 2025. A new integrated healthcare services contract expanded access to behavioral and physical health supports, and by 2023, all meals were freshly prepared onsite.

2024–2025 - Workforce Wellbeing and Continued Innovation: Recognizing staff wellbeing as central to sustainable reform, the Board directed evaluations of workload and mental health supports 2/24/2024 (16). Organizational restructuring and updated classification models aligned staff roles with youth development goals. The department implemented a therapy canine to serve youths and staff in the institutions. In early 2025, the new Integrated Healthcare Services (IHS) unit launched under a dedicated Medical Director, marking a major milestone in transforming care delivery.

STAFFING REALIGNMENT AND WORKFORCE RECOVERY: During 2021-2022, two pivotal events significantly impacted the Department's workforce: the Senate Bill 823 realignment and a temporary inability to conduct in-person academies and exams for applicants due to public health restrictions during the COVID-19- pandemic. These events contributed to a vacancy rate of approximately 20% in officer classifications within juvenile institutions. In October 2023, the Department transitioned all staff in correctional officer classifications into a unified Deputy Probation Officer model as part of a strategic effort to address vacancies and align staffing with the expanded responsibilities required in juvenile facilities.

During FY 2023-24, Probation filled 275 positions, including 181 sworn and 94 non-sworn staff, reducing the vacancy rate from 20% to less than 7%. With the significant number of new officers, the Department prioritized training and early wellness integration. This included incorporating wellness into onboarding, hosting a Family Wellness Day for employees and their families, and launching a dedicated Wellness App to support employee mental and physical health. Ongoing offerings such as fitness activities, peer support, webinars, and wellness trainings continue to promote workforce resilience.

ADVANCING SAFER PRACTICES

ELIMINATING THE USE OF CHEMICAL AGENTS IN JUVENILE FACILITIES

Background and Purpose: Building on nearly a decade of work to reduce reliance on force and promote safer environments for youth, Probation, at Board direction, is developing a plan to phase out the use of oleoresin capsicum (OC) spray in juvenile detention facilities by 2027. This effort directly aligns with the YICPM and national best practices in juvenile justice reform.

OC spray, while permitted under Title 15 of the Board of State and Community Corrections (BSCC) and the Department's Policy 514.8.1, is to be used only in situations of imminent threat where there are safety risks to youth or others and de-escalation is not possible. However, it is acknowledged that this practice is increasingly incompatible with Probation's long-term goals of trauma-informed, developmentally appropriate care, and best practices. In alignment with the YICPM, Probation is developing a phased plan to eliminate OC spray in all youth detention facilities by 2027. This plan was initiated following the Board's 8/26/2025 (26) directive and reflects a broader commitment to continuing the shift toward therapeutic approaches.

Policy and Practice Shifts in Progress: In support of this plan, Probation has already completed several foundational actions outlined in the YICPM. These include drafting and implementing a comprehensive crisis management policy; establishing clear limits on the use of room confinement to deescalate youth behavior; conducting high-quality investigations of all allegations of staff misconduct related to crisis incidents; and prohibiting the use of fixed restraints.

Additional implementation efforts are currently underway. These include providing intensive, trauma-informed training for staff; establishing consistent debriefing processes with both staff and youth following crisis events; piloting the use of specialized teams or protocols for safety interventions in high-risk scenarios; and advancing the prohibition of chemical agents in all facilities.

Stakeholder Engagement: The Probation Department has initiated broad stakeholder engagement to inform the proposed plan for the elimination of OC Spray in juvenile detention facilities. On September 12, 2025, Probation met with CJJA to begin mapping foundational elements of a proposed plan and confirm CJJA's role in providing ongoing guidance and technical assistance in this effort.

This work will be developed collaboratively and shaped by input from key partners, including community-based organizations, youth advocates, and service providers that support system-involved youth, as well as staff and officers of the Probation Department, the Probation Officers Association (POA), Supervising Probation Officers Associations (SPOA), County Counsel, Juvenile Court, Public Safety Group, Health and Human Services Agency, Child and Family Well-Being Department, District Attorney's Office, Office of the Public Defender, the Office of the Alternative Public Defender, and San Diego County Office of Education..

REDUCING ROOM CONFINEMENT AND USE OF FORCE

Room Confinement Practices and Oversight: Room Confinement is defined and guided by Welfare and Institutions Code (WIC) section 208.3 and Department policy, which both restrict its use to cases where less restrictive options have been exhausted or are unsafe. Room confinement is defined as the placement of a minor or ward in a locked sleeping room or cell with minimal or no contact with persons other than correctional facility staff and attorneys, excluding brief periods required for routine institutional operations. Per WIC 208.3, room confinement may not be used as punishment, coercion, convenience, or retaliation, and must follow clear protocols to ensure youth safety, well-being, and timely reintegration.

The Department regularly evaluates room confinement data against national averages through the Center for Improving Youth Justice Performance Based Standards (PbS) and the Council of Juvenile Justice Administrators. Under WIC 208.3, a minor or ward may be held in room confinement up to four hours, with longer periods of time requiring consultation with mental health or medical staff and development of an individualized plan for reintegration. For the most recent PbS data collection (April 2025), both County youth facilities were well below this threshold and national field averages: 1.37 hours at East Mesa (EM) compared to 3.59 hours nationally for youth detention facilities, and 1.31 hours at the Youth Transition Campus (YTC) compared to 9.36 hours nationally for youth commitment facilities.

The Probation Department is committed to minimizing the use of room confinement and continues to implement a range of strategies that prioritize de-escalation, early intervention, and individualized supports for youth in crisis. In support of this, current policy on room confinement requires prior approval, documentation, and frequent reassessment of the youth's readiness to return to the general program. The YICPM acknowledges that at times, de-escalation may require space, rather than dialogue, and that short-term separation can be a necessary safety measure rather than disciplinary sanction.

Use of Force Policies and Safeguards: Under Department Policy 514.3, officers may use force only when reasonably necessary to accomplish a legitimate governmental purpose, such as to protect the safety of youth, staff, or others, or to maintain institutional security. Staff must also consider any known youth vulnerabilities, such as age, mental health, or medical conditions, when determining the appropriate

response. Use of force is prohibited as punishment, discipline, retaliation, or treatment and may only be used in situations where de-escalation has failed or is not possible and imminent harm is likely.

Stakeholder Engagement: The Probation Department will engage with internal and external stakeholders to reduce and deemphasize the use of force and room confinement in youth detention facilities. This will include engagement with departments from HHSA, the Public Defender’s Office, San Diego County Superior Court – Juvenile Division, and the District Attorney’s Office. As part of the next phase of this work, the Department will expand outreach to additional external partners, including community-based organizations, youth advocates, and service providers that support system-involved youth.

IMPLEMENTATION PLAN

Building on the County’s commitment to youth-centered, trauma-informed care, the following two-year plan outlines a unified, phased approach that integrates efforts to reduce use of force incidents, ensure room confinement practices align with best practices and legal standards, and support the eventual elimination of OC spray in all youth facilities. This plan incorporates pilot testing, workforce training, stakeholder engagement, and policy reform to support a safe and sustainable system transformation.

The full 24-month implementation plan, beginning October 1, 2025, concluding September 30, 2027, including quarterly deliverables, milestones, and performance tracking measures, is provided as a separate attachment accompanying this memo. The high-level summary below provides a brief overview of the plan’s structure and intent.

Future Reporting: The Probation Department will provide quarterly updates to the Board on implementation progress related to the integrated plan for the phased elimination of OC Spray and the broader efforts over two years and best practices both short- and long-term to reduce and deemphasize the use of force and room confinement. In addition, Probation will return to the Board annually to review preliminary outcomes, discuss challenges, and recommend any necessary adjustments to support long-term success.
