B-29 - Fees, Grants, Revenue Contracts - Department Responsibility for Cost Recovery

BOARD POLICY STATEMENTS:

Board Policy B-29 mandates that departments recover the full cost to the extent legally possible for services provided to agencies or individuals outside the County of San Diego under grants, contracts, or for which fees may be charged. Reimbursement by fees, contracts, and grants will be for the full cost of all services, with certain exceptions approved by the Board of Supervisors. Annual review of rates and levying of special assessments through the tax rolls, ensures districts are full cost recovery.

MANDATORY COMPLIANCE:

California Health and Safety Code, Section 5473, requires the Board of Supervisors and the Board of Directors to adopt resolutions authorizing collection of charges on the annual property tax roll. Certification of the tax roll must be submitted to the Auditor and Controller by August 10th.
