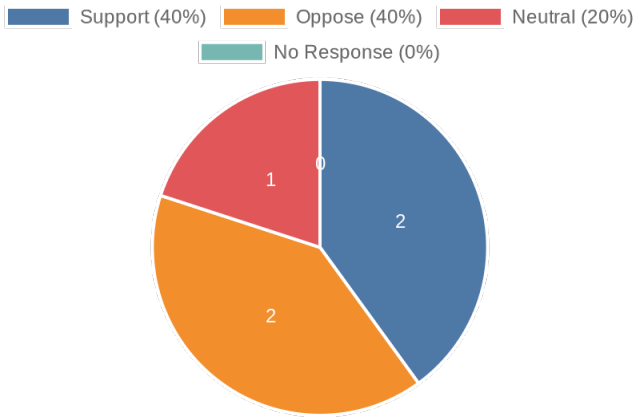

Overall Sentiment

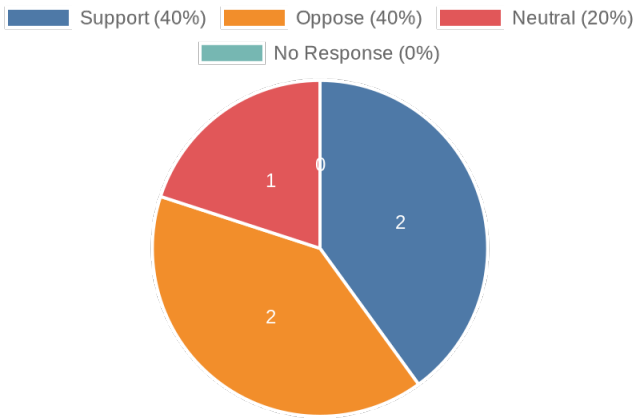

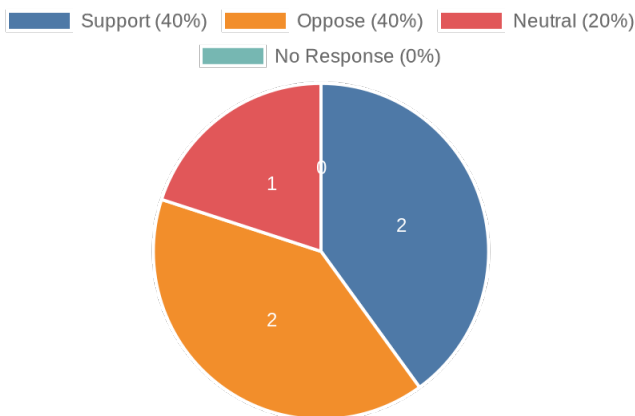
