

Overall Sentiment







I worked at a children's advocacy center in child abuse prevention, where I saw the vital impact of legal measures that prioritize survivor support. AB 379 rightly recognizes minors as victims of commercial sexual exploitation, not criminals. Diverting fines to a Survivor Support Fund and offering diversion for adults will better prevent exploitation and support survivors. A Polaris Project survey revealed 42% of trafficking survivors had criminal records, with 90% saying their records stemmed from their exploitation ("In Harm's Way: How Systems Fail Human Trafficking Survivors," 2023). AB 379 could do a lot more - e.g., its focus on loitering perpetuates outdated stereotypes of sex buyers circling around a city block, while research shows solicitation has largely shifted online. I hope your letter urges co-sponsors to address online dynamics that are less visible. Overall, though, this bill is a step in the right direction.
