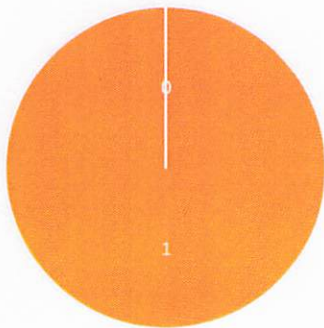

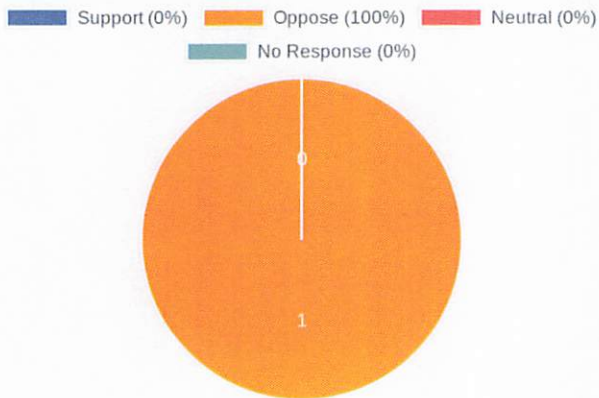

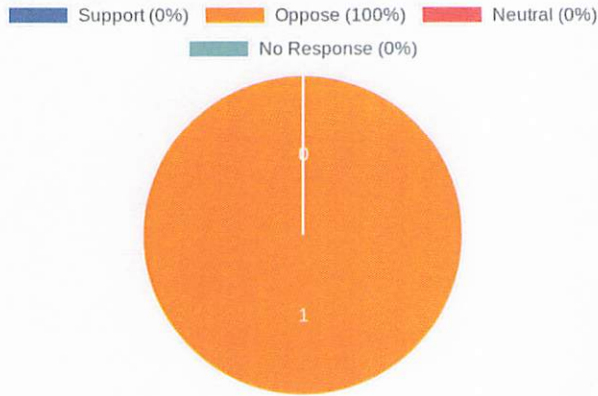

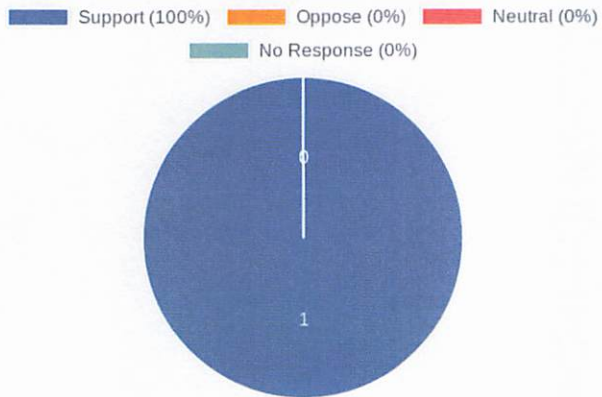

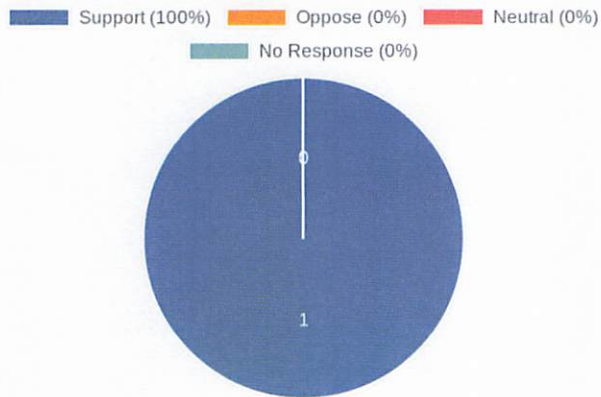

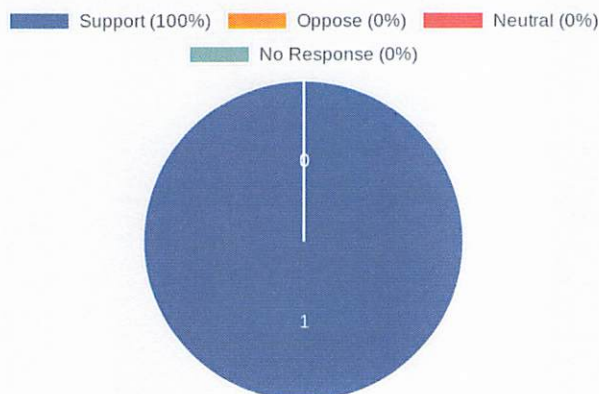

Has there been any consideration around strengthening the referral and care coordination layer alongside these efforts?
